

For the World Heritage property Natural and Culturo-Historical Region of Kotor (Montenegro)

1. Executive Summary of the report

Following the World Heritage Committee Decision 42 COM 7B.26 adopted during the last session of the Committee held in Bahrain last year (June 24th – July 04th), there were several crucial activities conducted by the state party in order to access the policies and respond to the requests defined by the last and previous Decisions on the Natural and Culturo-Historic Region of Kotor.

The main focus was on the organization of the Reactive Monitoring Mission of the World Heritage Centre, ICOMOS and UNESCO Regional Bureau for Science and Culture in Europe, which was organized from October, 29th - November, 02nd, 2018 (Annex I).

In December 2018 Regional Workshop on Heritage Impact Assessment was organized in Kotor, led by two ICCROM experts and organized with the support of UNESCO World Heritage Centre and UNESCO Regional Bureau for Science and Culture in Europe (Annex II).

The procedure of drafting of the Spatial Plan for the Municipality of Kotor will be finished by 5th of April, when the document, upon its adoption on Government Session will be sent to UNESCO for the opinion and suggestions which are to be incorporated in the final version of the document and sent to UNESCO for its final approval.

The project proposal for the cable car from Kotor Old Town to St. John Fortress was officially abandoned (Annex III).

The process of preparation of the new Amendments of the Law on Protection of Natural and Culturo-historic Region of Kotor, based on the Report of the Mission, has already started (Annex IV).

The process of revision of the Management Plan for the Natural and Culturo-Historic Region of Kotor has started, as requested by the Report of the Mission (Annex V).

2. Response to the Decision of the World Heritage Committee

a) Notes the proposal to centralize the production of HIAs as a means of mitigating negative impacts of development proposals that have been submitted, but considers that this measure cannot compensate for the lack of adequate legal and planning mechanisms for the overall landscape of the property.

Intention to introduce HIA methodology into the national legislative system was established in order to avoid preparation of HIAs by private companies/investors, which was previously the case, not to centralize the process. According to the *Amendments of the Law on Protection of Natural and Culturo-historic Region of Kotor*, HIA is being prepared by the Expert team formed by the Administration for the Protection of Cultural Properties, upon the request of investor. If the Administration concludes that the potential project could have impacts on OUV, it forms the Expert team with the assignment to produce HIA. Fees for the preparation of HIA are provided by investors and funds go directly to the State Treasury.

This measure was not invented to compensate the lack of legal and planning mechanisms, but to help the process of identification of potential threats to OUV, especially having in mind that the Spatial plan of Municipality of Kotor is not on the force and that some of the lower plans which are on the force are not appropriate, which is recognized by the previous Decision of WHC, by Draft HIA for whole area and by the Report of Reactive Monitoring Mission delivered in February 2019.

In addition, previous Decisions of the World Heritage Committee requested from the State Party adoption of HIAs for individual sites within the protected area, but also comprehensive HIA for whole area. In the moment when these requests were taken into consideration, there was no legal position in legislative system which could be used as a platform for tepreparation and adoption of HIA. That is why the Government had to adopt draft HIA for whole area, prior to sending it to UNESCO. Upon receiving of the Report of WHC on proposed HIA for whole area, Expert team started with the implementation of suggestions given by WHC, and this process is still ongoing. As stated by the previous information sent to UNESCO, the Amendments of the Law on Protection of Natural and Cultural-historic Region of Kotor which were adopted last year had introduced HIA as a regular procedure within the planning and protection system for the area.

Finally, in order to further develop skills and knowledge for preparation of HIAs, Regional Workshop was organized in Kotor in December 2018, with wide participation of all relevant stakeholders. The Workshop was led by two ICCROM experts and it was organized with the support of UNESCO World Heritage Centre and UNESCO Regional Bureau for Science and Culture in Europe (Annex II).

b) Remains concerned that considerable further work is needed to analyze in detail the weaknesses of the current Spatial and Urban Plans in force for the property's territory and its buffer zone, as a prelude to developing means to strengthen them;

Draft Spatial plan for the Municipality of Kotor was developed by the Expert group formed by the Ministry of Sustainable Development and Tourism and sent to the relevant institutions for their opinions and suggestions. Before transmission of the document, this Ministry has launched and implemented the procedure of Previous Public Participation on the concept of the Spatial Plan for the Municipality of Kotor. This consultation process lasted for one month and represented the opportunity for wider public to give suggestions based on the proposed draft document. Of utmost importance for the finalization of the Draft Spatial Plan was the Report of the Reactive Monitoring mission, which was also shared with the Expert group dealing with the Spatial Plan, upon delivering of the document to the member state. Draft document was then additionally improved and sent to relevant stakeholders for their opinions. The document received several comments and interventions by the stakeholders within this process, which are currently being integrated in the document. It is expected that the Draft Spatial Plan for the Municipality of Kotor will be presented to the Government and adopted on its next Session, and then sent to UNESCO by 5th of April, at the latest. In parallel with its elaboration by UNESCO, Ministry of Sustainable Development and Tourism will carry out second public debate, in order to open possibility for the wider public to express their suggestions and opinions on more developed document comparing to the first cycle. Upon completion of public debate and UNESCO comments and interventions, document will be once again improved and sent to UNESCO for its final approval, before it is officially adopted on the state level.

Although the document will be sent within the week from this Report, it is important to underline that the Draft Spatial Plan predicts, upon its final adoption, putting out of force lower planning documents which are not in line with the Spatial Plan of Kotor.

Studies of protection of cultural properties are the basic documents for the elaboration and scoping of spatial plans. Studies of protection for the Spatial Plan for the Municipality of Kotor and for The Spatial Plan of Special Purpose for Coastal Area were previously delivered to UNESCO.

Studies of protection of cultural properties for the municipalities of Cetinje and Herceg Novi are adopted, while the study of protection for the Municipality of Tivat is under elaboration.

Considering the importance of buffer zone of the area and having in mind the Report of Reactive Monitoring Mission, special consideration will be given to the analyses of policies of protection in buffer zone. This question will be more preciously defined within the new *Amendments of the Law on Protection of Natural and Culturo-historic Region of Kotor*, which are currently being prepared by the Working Group formed by the Ministry of Culture (Annex IV), using the Report of the Reactive Monitoring Mission as a guidance for detailed consideration within this issue. Special attention to the buffer zone will be given through the activity led by Administration for the Protection of Cultural Properties and the Ministry of Culture, aimed on the assessment on current needs, threats and ongoing policies within the buffer zone, defined by the priorities of sites and

interventions. This activity will be implemented for the purposes of the new amendments to the Law in order to further precise procedures for the Administration. This activity will be realized within cooperation of experts from the institutions and from civil society.

Buffer zone will be also further targeted within the Revision of the Management Plan for the Natural and Culturo-Historic Region of Kotor, which is ongoing process (Annex V).

c) Considering ICOMOS' technical review of the HIA of the project, <u>urges</u> the State Party to abandon the Kotor-St John's Fortress cable car project to prevent any negative impact on the property's Outstanding Universal Value (OUV);

The project of the cable car from Kotor Old Town to St. John Fortress, submitted by the Municipality of Kotor in 2016, was officially abandoned by proposing institution (Annex III).

d) <u>Strongly requests</u> the State Party to maintain the moratorium on any new construction and development until a complete suite of planning and protection measures are in force to satisfactorily accommodate possible sustainable developments within the sensitive landscape of the area and prevent any impact on the cultural and landscape values of the property;

As suggested by the Reactive Monitoring Mission and requested by their Report, the moratorium on new constructions will be on force until the Spatial Plan for the Municipality of Kotor is finally adopted, as well as the Revision of the Management Plan for the Natural and Culturo-Historic Region of Kotor is finalized and approved by UNESCO.

e) Also requests the State Party to complete all relevant actions in response to the Committee's previous decisions, in particular to carry out HIAs for all ongoing or planned development projects, including the transport connection at Verige and the tourist facility at Glavati - Prčanj, as well as to submit the results of the HIAs to the World Heritage Centre, for review by the Advisory Bodies, prior to undertaking any further commitments;

The HIA for the site Glavati was delivered to UNESCO in September 2018. The Technical Review on HIA by ICOMOS was delivered to the state party in December 2018. According the position stated in the Technical Review and the Report of Reactive Monitoring Mission which additionally confirmed the previous conclusions, the project is abandoned within the draft Spatial Plan for the Municipality of Kotor.

HIA for Verige bridge will be delivered to UNESCO upon its elaboration.

f) Further requests the State Party to invite a joint World Heritage Centre/ICOMOS Reactive Monitoring mission to the property to assess its state of conservation, as well as the various reports and legal amendments that have been produced and to advise on what further work is needed to strengthen the legal and planning protection of the property and its buffer zone and to coordinate its management;

The invitation for the Reactive Monitoring Mission was sent in July 2018, upon the closure of the last session of the World Heritage Committee. The mission was organized between 29th October and 02th November 2018 and it was organized with particular aim to access the information on all legal and planning questions and to conduct detailed field work (Annex I).

The Report of the Mission was delivered in February 2019 and it is already widely used by different stakeholders.

The authorities of Montenegro are grateful for the detailed Report given by the Mission which is of utmost importance for the streamlining of the current and future policies for the protection and management of the Region.

g) <u>Finally requests</u> the State Party to submit to the World Heritage Centre, by 1 February 2019, an updated detailed report on the state of conservation of all components of the property and the implementation of the above, for examination by the World Heritage Committee at its 43rd session in 2019;

Following announcement letter previous to this Report, the process of reporting had to be extended because of the delivering of the Report of the Mission which was crucial for this document, since it defined specific tasks and the deadlines, directly connected to the SoC Report and which had to be incorporated in the definition of the future tasks and the activities.

3. Other current conservation issues identified by the State(s) Party(ies) which may have an impact on the property's Outstanding Universal Value

All conservation issues identified by the State are in details elaborated in draft HIA for whole area which was previously delivered to UNESO and by the Action plan adopted by the Government in 2017, also delivered to UNESCO. Conservation issues were also openly shared with the reactive Monitoring Mission and reflected in their report.

4. In conformity with Paragraph 172 of the *Operational Guidelines*, describe any potential major restorations, alterations and/or new construction(s) intended within the property, the buffer zone(s) and/or corridors or other areas, where such developments may affect the Outstanding Universal Value of the property, including authenticity and integrity.

Major restorations, alterations and/or new construction(s) intended within the property identified by the State are in details elaborated by the Reactive Monitoring Mission in their Report.

5. Public access to the state of conservation report

Authorities of Montenegro agree to put the Report on the website.







II Zadatak Radne grupe je da izradi tekst Predloga zakona o izmjenama i dopunama Zakona o zaštiti Prirodnog i kulturno-istorijskog područja Kotora.

III Radna grupa je u obavezi da povjereni posao iz stava 2 dispozitiva ovog Rješenja, izvrši do 3. maja 2019. godine.

IV Administrativno-tehničke poslove za potrebe Radne grupe, obavljaće Direktorat za kulturnu baštinu.

Obrazloženje

Odredbama člana 56 Uredbe o organizaciji i načinu rada državne uprave, propisano je da se za vršenje poslova u okviru kojih se zahtijeva stručna saradnja državnih službenika i namještenika iz različitih unutrašnjih organizacionih jedinica, mogu obrazovati projektne grupe, timovi ili drugi odgovarajući oblici rada i da projektnu grupu, tim ili drugi oblik rada obrazuje potpredsjednik Vlade, ministar, odnosno starješina samostalnog organa uprave. U radu projektne grupe, tima ili drugog oblika rada, mogu se angažovati i stručnjaci izvan organa državne uprave.

S tim u vezi, ministar kulture je obrazovao Radnu grupu za izradu Predloga pravilnika o bližem načinu isticanja, upotrebe, kao i sastav materijala zastave, sa zadatkom koji je određen u stavu 2 dispozitiva ovog rješenja.

Shodno izloženom, a imajući u vidu važnost očuvanja Prirodnog i kulturno-istorijskog područja Kotora, riješeno je kao u dispozitivu.
