[Answer 1 in English]

The State Party wishes to confirm that the communities concerned are indeed informed of and gave their consent to the inscription of the element on the List of Intangible Cultural Heritage in Need of Urgent Safeguarding. Initially, the Buklog thanksgiving ritual was intended for inscription to the Representative List of Intangible Cultural Heritage of Humanity. However, during

consultations among community members on the status and viability of the element, numerous grave threats, including human-induced and natural hazards, were identified. As indicated in the nomination file, these threats include armed conflicts which cause displacement of the Subanen from their ancestral homelands and the downturn of harvest and farm productivity because of climate extremities and natural disasters. Additionally, the practice of Buklog has been discouraged by Christian churches in some municipalities. Noting these, the communities decided that the element be nominated to the Urgent Safeguarding List to enhance feasibility and transmission of the element. The initial consent forms were not updated accordingly to reflect this decision arrived at by the concerned communities. The State Party shall provide the Evaluation Body and the Intergovernmental Committee with the signed and updated consent forms from the Subanen communities regarding the nomination of Buklog to the List of Intangible Cultural Heritage in Need of Urgent Safeguarding.

[Réponse 1 en français]

L'Etat partie confirme que les communautés concernées ont effectivement été informées et qu'elles ont donné leur accord concernant l'inscription de cet élément sur la Liste du patrimoine culturel immatériel nécessitant une sauvegarde urgente. A l'origine, le rituel de gratitude « Buklog » devait être proposé pour inscription sur la Liste représentative du patrimoine culturel immatériel de l'humanité. Cependant, lors des consultations entre les membres des communautés sur le statut et la viabilité de cet élément, de nombreuses menaces graves, tels que des risques liés à l'action humaine et des risques naturels, ont été identifiés. Comme indiqué dans le dossier de proposition, ces menaces comprennent les conflits armés qui provoquent le déplacement des Subanen de leurs terres ancestrales, et la baisse de la productivité agricole due à la dureté du climat ainsi qu'aux catastrophes naturelles. Dans certaines communes, les églises chrétiennes découragent en outre la pratique du Buklog. Suite à ces observations, les communautés ont décidé que l'élément serait proposé pour inscription sur la Liste de sauvegarde urgente afin d'accroître sa pratique et la transmission. Les formulaires de consentement initiaux n'avaient pas été mis à jour en conséquence et ne reflétaient par conséquent pas cette décision prise par les communautés concernées. L'État partie fournira à l'Organe d'évaluation et au Comité intergouvernemental les formulaires de consentement mis à jour et signés par les communautés des Subanen concernant la proposition d'inscription du Buklog sur la Liste du patrimoine culturel immatériel nécessitant une sauvegarde urgente.

DECLARATION OF CONSENT

We, the recognized Timuay, Balyan and other members of the Subanen territories located in the Municipalities of Kumalarang, Lakewood, Aurora and Ramon Magsaysay in the Province of Zamboanga del Sur; the Municipalities of Naga and Kabasalan in the Province of Zamboanga Sibugay; and from the Municipalities of Sindangan and Siayan in the Province of Zamboanga del Norte, hereby declare that:

Whereas, the Buklog is considered by us as the most esteemed and elaborate socio-religious ceremony of all indigenous Subanen living within the Zamboanga Peninsula in order to appease the Dwata Magbabaya, our Supreme God of all Creation;

Whereas, the traditional Buklog is generally celebrated as a thanksgiving ceremony in reverence to our God for all the blessings, protection from danger, healing of illnesses, and for our unity as a people. This sacred ritual is also done as our way of asking the Supreme Being to free the soul of someone who passes away from any earthly or material burden.

Whereas, we acknowledge that the Buklog is a living tradition that is still being practiced in most of the Subanen communities in the Zamboanga Peninsula and considered as the embodiment of our collective identity as Subanen;

Whereas, during the holding of our joint Buklog, aptly called Buklog Tend'g, held in the Municipality of Kumalarang, Zamboanga del Sur on the 4 of March 2018, we collectively sanctify our affirmation of unity as members of the Subanen Tribe;

We therefore declare our collective consent to nominate the Subanen Buklog as our living tradition to the UNESCO's List of Intangible Cultural Heritage in Need of Urgent Safeguarding.

ENDORSEMENT

Whereas, the State shall recognize, respect and protect the rights of indigenous cultural communities to preserve and develop their cultures, traditions and institutions as enshrined in the 1987 Constitution of the Republic of the Philippines;

Noting that, the Republic Act 10066, known as the National Cultural Heritage Act of 2009, mandated the Local Government Units to conduct an inventory of the cultural resources within its jurisdiction as well as to implement measures for the conservation of the cultural assets of the communities;

Consistent to the provisions of the International Convention for the Safeguarding of Intangible Heritage of Humanity duly promulgated in 2003 in Paris, that defines intangible heritage as the cultural practices, representations, expressions, knowledge and skills, as well as the instruments, objects and artifacts associated therewith, that communities, groups and individuals that are recognized as part of their cultural heritage, and as such shall be safeguarded;

Being aware that the traditional practice of the **Buklog**, the most elaborate and highest ritual of thanksgiving that is considered as a complex is a body of rituals and ceremonies that marks the stages of life in Subanen society and primarily reveals aspects of their individual and collective cultural identity as a people;

In recognition of the mandate of the National Commission for Culture and the Arts to "regulate activities inimical to preservation/conservation of national cultural heritage/properties and pursue partnership with the various Local Government Units in the conservation and safeguarding of the people's cultural heritage;

In support to the indigenous Subanen Leaders and Shamans in several territories within the Zamboanga Peninsula, particularly in the Municipalities of Sindangan, Siyayan, Aurora, Lakewood, Kumalarang, Naga, Ramon Magsaysay and Kabasalan, in consultation with their constituents, have decided to conduct a thorough documentation of the indigenous Subanen Buklog Ritual for its inclusion in the List of Intangible Cultural Heritage in Need of Urgent Safeguarding;

Admitting that some of the constituents of the Municipality of Aurora belong to the Subanen population who possess unique cultural traditions and are still practicing their traditional Buklog celebration;

Now therefore, the Office of the Vice Mayor of the Municipality of Aurora, strongly supports the initiatives of the indigenous Subanen communities, who are residing within and outside of the Municipality, in the documentation and safeguarding of their traditional Buklog rituals.



In recognition of the mandate of the National Commission for Culture and the Arts to "regulate activities inimical to preservation/conservation of national cultural heritage/properties and Pursue partnership with the various Local Government Units in the conservation and safeguarding of the people's cultural heritage;


