CONFERENCE OF PARTIES TO THE CONVENTION ON THE PROTECTION AND PROMOTION OF THE DIVERSITY OF CULTURAL EXPRESSIONS

Seventh session
Paris, UNESCO Headquarters, Room II
4-7 June 2019

Item 15 of the provisional agenda: Election of the members of the Committee

Pursuant to Rule 16 of its Rules of Procedure, the Conference of Parties elects half of the States Members of the Committee every two years.

Decision required: paragraph 12

1. In accordance with Article 23, paragraphs 1 and 4 of the Convention, the Conference of Parties elected, at its first session, an Intergovernmental Committee for the Protection and Promotion of the Diversity of Cultural Expressions, hereinafter referred to as “the Committee,” composed of 24 members. Since then, there have been six elections. An overview of the results is provided in Annex I.
2. In accordance with Rule 17.1 of the Rules of Procedure, the Secretariat requested all States Parties, three months before the opening of the present session of the Conference of Parties, whether they intended to stand for election to the Committee. The provisional list of candidates is provided in document DCE/19/7.CP/INF.3. In accordance with Rule 17.3, the provisional list will be finalized 48 hours before the opening of the Conference of Parties. No candidacy will be accepted in the 48 hours preceding the opening of the Conference.
3. Rule 16 of the Rules of Procedure of the Conference of Parties provides that the **term of office** of the States Members of the Committee is four years, in accordance with Article 23.1 of the Convention, and that “a Member cannot be elected to two consecutive mandates unless a regional group presents a ‘clean slate.’” A clean slate means that the number of candidates is the same as the number of vacant seats.
4. Rule 15 of the Rules of Procedure of the Conference of Parties provides for **election on the basis of the composition of the electoral groups** of UNESCO, as determined by the UNESCO General Conference. In accordance with the practice of the UNESCO General Conference, Group V is composed of two subgroups, V(a) for African States and V(b) for Arab States.
5. The voting system is based on the **pro rata principle**, under which the number of Parties in each electoral group is divided by the number of States Parties to the Convention and then multiplied by the number of available seats. As of 4 June 2019, the Convention is in force in 145 States Parties and 1 regional economic integration organization (see Annex II).
6. In accordance with Rule 15 of the Rules of Procedure, for the purposes of the election of the Members of the Intergovernmental Committee at the seventh session of the Conference of Parties, the **24 seats are distributed according to the pro rata principle** among the six electoral groups (see Annex III). In view of the regional grouping of the 145 States Parties, the *pro rata* calculation of the number of States Parties in each group would allocate between 2,318 and 6,290 seats to each electoral group.
7. With regard to the distribution of seats within the Committee, however, **Rule 15.2 of the Rules of Procedure** of the Conference of Parties provides for a minimum of three seats and a maximum of six seats per electoral group.
8. At its second session, when electing the Members of the Committee, the Conference of Parties considered that Rule 15.2 of the Rules of Procedure should be applied to ensure that a minimum number of seats (3) be allocated to each electoral group and that the remaining seats be allocated *pro rata* to the other electoral groups (see detailed summary record of the second session of the Conference of Parties to the Convention on the Protection and Promotion of the Diversity of Cultural Expressions, [CE/11/3.CP/209/4](#), paragraph 110).
9. The Conference of Parties used this method when renewing the Committee’s membership at the elections held during the third, fourth, fifth, and sixth sessions of the Conference of Parties (see detailed summary record of the third session of the Conference of Parties, [CE/13/4.CP/4](#), paragraph 152, the detailed summary record of the fourth session of the Conference of Parties, [CE/15/5.CP/4](#), paragraph 303, the

detailed summary record of the fifth session, [DCE/17/6.CP/4](#), paragraph 272 and the draft summary record of the sixth session (DCE/19/7.CP/4) .

10. For the purpose of the election of Members of the Committee at this seventh session, and in application of Rule 15.2, the Conference of Parties may consider applying *pro rata* allocation of the remaining six seats as follows:

Calculation methods in the application of Rule 15.2

* *Total number of States Parties (SP) from each electoral group ÷ Total number of States Parties = the proportion of States Parties from each electoral group*

** *Maximum number of seats (6) to be distributed among electoral groups x the proportion of States Parties from each electoral group = additional number of seats to be allocated pro rata*

*** *Minimum number of seats per electoral group + total number of additional seats to be allocated pro rata = total number of seats to be allocated per electoral group*

11. The Conference of Parties will be required to agree on the distribution of the total number of vacant seats per electoral group. To this end, it may take into account Rule 15.2 of the Rules of Procedure and if so, the calculations presented in the table in paragraph 10.

12. The Conference of Parties may wish to adopt the following resolution:

DRAFT RESOLUTION 7.CP 15

The Conference of Parties,

1. *Having examined Document DCE/19/7.CP/15 and its Annexes;*
2. *Decides that, for the purposes of the election of the Members of the Committee at this session, the 12 seats will be distributed among the electoral groups as follows: Group I (...); Group II (...); Group III (...); Group IV (...); Group V(a) (...); Group V(b) (...).*
