Item 1 of the provisional agenda: Election of a Chairperson, one or more Vice-Chairperson(s) and a Rapporteur of the Conference of Parties

Decision required: paragraph 5

- 1. In accordance with the Rules of Procedure of the Conference of Parties (Rule 5), the Conference shall elect a Chairperson, one or more Vice-Chairperson(s) and a Rapporteur.
- 2. The Conference of Parties may wish to consider electing a Bureau comprising a total of six members, that is, one member from each of the electoral groups established by the General Conference of UNESCO.
- 3. The term of office of the Chairperson, the Vice-Chairperson(s) and the Rapporteur will run from the opening of the current session until the opening of the next session of the Conference of Parties, when a new Bureau will be elected.
- 4. For information, the members of the Bureaus from previous sessions (2007-2017) are presented in Annex.
- 5. The Conference of Parties may wish to adopt the following resolution:
