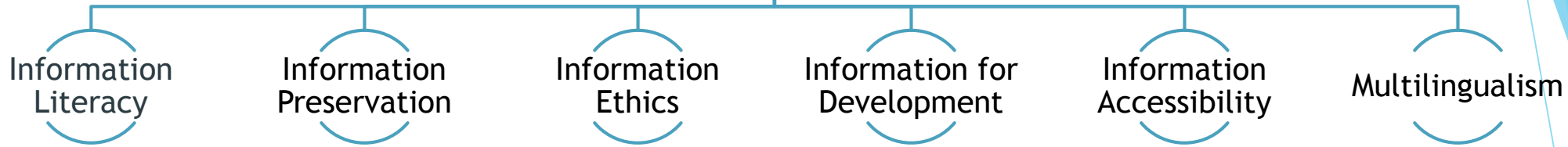

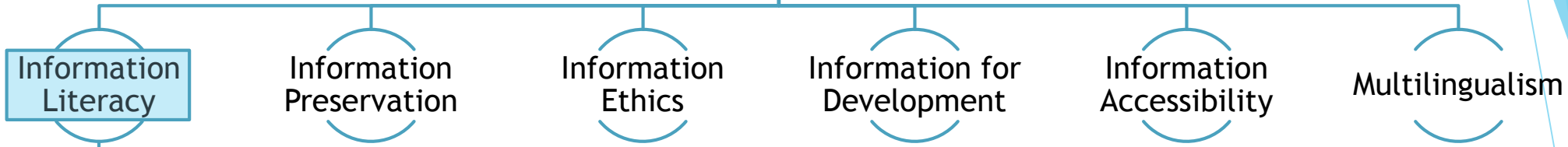
IFAP's Priority Areas



Some Overarching IFAP Targets for 2016-2017

1. Support capacity-building of National IFAP Committees (new or existing ones) to address their national policy needs
2. Establish formal partnerships with regional/international institutional partners and develop joint programmes of work
3. Support Member States to integrate UNESCO policies in their national information strategy
4. Train policy-makers in using the IFAP National Information Society Policy Template and other IFAP / UNESCO resources and tools

UNESCO Global MIL Assessment Framework: Country Readiness and Competencies



MIL Assessment in Latin America and the Caribbean (LAC)

- ▶ MIL Assessment of country readiness and enabling environment, and teachers' competencies in LAC region
- ▶ Joint CI and ED initiative
- ▶ 7 pilot countries: Brazil, Colombia, Ecuador, Grenada, Guatemala, Honduras, Chile and Peru
- ▶ Policy formulation and revision of teacher training programmes, development of materials and tools
- ▶ Meeting of national focal points in Guatemala (24-25 September 2015)
- ▶ Final results expected in September 2016

ICT in Education - ICT CFT

1. Teacher Training for integration of ICT in the classroom with a focus on the ICT Competency Framework for Teachers:

ICT CFT Harnessing OER Activities

- ▶ Continued roll out of the of the ICT CFT harnessing OER initiative started in 2013: 7 countries to have implemented project
- ▶ Development of a web-based tool to share OER which support the national implementation of the ICT CFT
- ▶ Training of regional and/or national experts covering at least 3 UNESCO Regions to support the contextualization of the ICT CFT harnessing OER

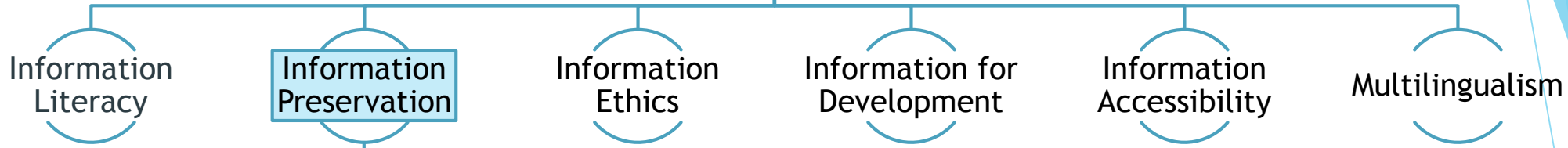
Revision and Finalization of the ICT CFT V3

- ▶ Stakeholder consultations on lessons learnt on the implementation of the ICT CFT Version 2
 - ▶ New developments, Lessons learnt, Recommendations for Version 3

2. Policy support for initiatives in open distance flexible and online education focusing on open solutions:

- ▶ Development of a Policy support resource Open solutions for ODL and ensuring inclusive Knowledge Societies
- ▶ Training on the implementation of the UNESCO Guidelines on the inclusion of students with disabilities in Open and Distance Learning (ODL) using open solutions
 - ▶ Ex. open educational resources, free and open source software

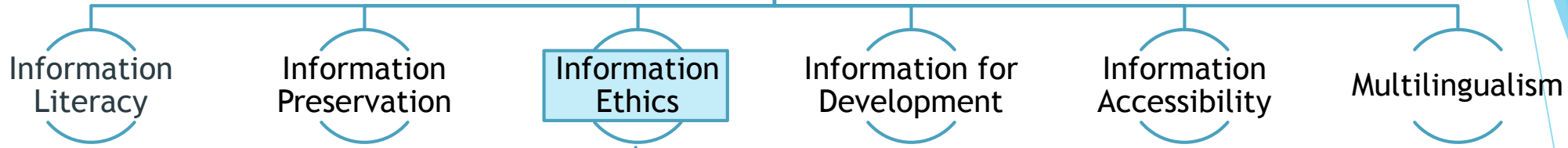

- ▶ UNESCO Memory of the World workshop to strengthen Maghreb countries capacities for promotion of documentary heritage
 - ▶ Two-day training workshop (31 March - 1 April 2016) at the Académie du Royaume du Maroc in Rabat in collaboration with the Moroccan National Commission for UNESCO
 - ▶ Gathered more than thirty participants from Morocco, Algeria, Mauritania and Tunisia, representatives of Maghreb national commissions, senior executives and professionals from archives, libraries, and audiovisual heritage institutions and ISESCO
- ▶ World Day for Audiovisual Heritage, 27 October 2016

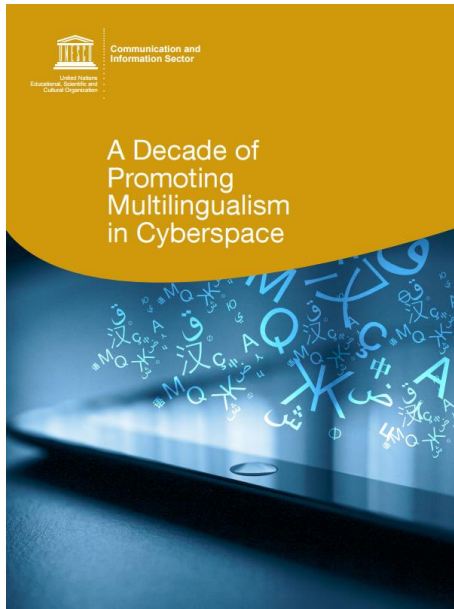


MULTILINGUISM

- ▶ Will contain full data on languages, policies, regulations, technical recommendations and best practices
- ▶ A new globally accessible and open online platform will be used for monitoring and promoting the world's languages online, strengthening cooperation and sharing knowledge using open and inclusive technological solutions among international, regional and national language institutions

IFAP & World Summit on the Information Society (WSIS) follow-up

- ▶ WSIS provides overall, global framework for UNESCO's intersectoral action and links directly to IFAP's six Priority areas
- ▶ United Nations General Assembly overall **WSIS+10 Review** (dec.'15):
 - ▶ CI's and IFAP's topics figure very prominently, including ICT4D, multilingualism, accessibility, ethics, information literacy
- ▶ WSIS Forum'16 - co-organized with ITU (host), UNDP and UNCTAD (2-6 May'15)
 - ▶ 1800 participants, 85 vice-ministers, all UNESCO co-chaired ministerial roundtable, all its sessions had a clear SDG focus, e.g.
 - ▶ SDG 16: Inclusive and peaceful societies - incl. ethical dimension, in cooperation with SHS and CLT



- ▶ UNESCO now chairs UNGIS (United Nations Group on the Information Society)
 - ▶ Focus: strengthening UN ICT coordination
- ▶ Internet Governance Forum (IGF) preparations: UNESCO building on the Internet Universality and ROAM (Rights-based, Open, Accessible, Multistakeholder shaped) principles adopted by the 38th General Conference
