






Background

- MEL Strategy is a tool for planning, managing, and documenting the collection and use of data through the standardization of:
 - data collection methods, verification protocols, and procedures for evaluation and improvement
- It is a document that describes a system which <u>links</u> <u>strategic information</u> obtained from various data collection systems to <u>decisions</u> that will improve education programs
- It is also the fundamental document that will hold the program <u>accountable</u> and tell you whether you <u>succeeded</u> or **not**

Goal and Objectives of the M&E Strategy

- Goal: to establish a M&E system for tracking progress and demonstrating results of the KIX Program and to ensure evidence-based decision making
- Objectives:
 - Outline various <u>roles</u> and <u>responsibilities</u> regarding M&E with a view to tracking progress and demonstrating results,
 - Use it as a tool for monitoring progress both in physical and financial terms (ensure <u>accountability</u>),
 - Use it as a communication tool for documenting the M&E mechanisms (encourage <u>transparency</u> and <u>responsibility</u>)
 - □ Ensure greater utilization of routine data sources (informed decision)
 - Strengthen the monitoring and Evaluation <u>culture</u>
 - Guide M&E implementation (Standardization and Coordination)

MEL Strategy: Outcomes and Outputs


Outcomes

- Promoting the practice of evidence-based decision making, policy development/adaptation and implementation;
- Reporting in time to IICBA (lead consortium), consortium members, member states and other partners;
- Objective decision making for performance improvement, planning and resource allocation; and
- Promoting accountability.

Outputs

- Prepare an M&E Action Plan
- A functional robust, comprehensive, and well-coordinated M&E system for KIX in place;
- Regular updates on performance indicators available
- Implementation progress reports are produced on time;
- Data sources outside the routine reporting are aligned to facilitate the end-line review and assess Program's impact

Assumptions and risks

- Inability to secure political commitment of developing country partners
- Inability to address the disparities in DCPs' political and educational environment
- Difference of perspectives of governments, civil society, donors and other stakeholders
- Unevenness of capacities of the different stakeholders within DCPs as well as DCPs and variations in the access and use of ICT infrastructure
- Need for additional resource mobilization to sustain hub activities

Anglophone Africa Knowledge and Innovation Exchange (KIX) regional hub serves as a regional forum that facilitates demand-driven cross-country knowledge exchange, learning, and collaboration using evidence and actionable research among key national education stakeholders.

KIX's Approach to MEL will be guided

- Results-oriented: Each of our indicators is linked to a specific result.
- Participatory: involves the entire project team, consortia, direct implementing partners and strategic partners in <u>data</u>
 <u>collection</u>, <u>interpretation</u>, <u>and in using MEL information</u>.
- Effectiveness: measure of the extent to which an <u>objective</u> has been <u>achieved</u> or the likelihood of being achieved.
- □ Efficiency: assesses the <u>outputs</u> in relation to <u>inputs</u>, within the context of <u>costs</u>, <u>time</u>, and <u>economic</u> and <u>financial</u> results.
- Sustainability: The KIX program has the explicit aim to develop models to deliver services that are sustainable beyond the project.

Monitoring

- Track <u>progress towards the agreed results</u> in the KIX matrix
- Checks if <u>assumptions made and risks identified</u> at the design stage are still valid or need to be reviewed
- Allows Consortium members and implementing partners to make <u>mid-course corrections</u> as an integral part of programme management

And Why Do we need monitoring?

- Consortium is responsible, with partners, to monitor achievement of results
 - Regular and systematic assessment of progress
 - Continued review of <u>member states and partners'</u>
 <u>capacity development needs</u>
 - ■Improve <u>results-based reporting</u> on achievements
 - ■Strengthen <u>teamwork and ownership</u> of the KIX among implementing partners and member states
 - Feeds into evaluation and real-time learning

Monitoring - Performance Indicators

Performance Indicators: Signposts of Change

- Inform decision making for ongoing project management
- Measure progress and achievements, as understood by the different stakeholders
- Clarify consistency between activities, outputs, outcomes and impacts
- Ensure <u>legitimacy</u> and <u>accountability</u> to all stakeholders by demonstrating progress
- Assess project and staff performance

Levels of Performance Indicators

Impact (#2)

- % of KIX Africa 19 hub member states that demonstrate strengthened national education systems to realize quality, inclusive and equitable education as a result of the KIX Hub Activities
- 2) Level of satisfaction among member states with the KIX hub activities

Outcomes (#10)

- **SO1**: % of member states engaged KIX's ways of collaborative learning, 6 months after KIX hub implementation
- 2) **SO1**: # of best practices produced and shared on quarterly basis by member states.
- sol: # of Regional KIX hub Thematic Networking/community practice groups established and functional (regular meeting/discussion)
- 4) **SO2**: % of member states sharing knowledge with other countries
- 5) SO2: % of member states that have participated in the establishment of regional innovation agendas
- 6) SO2: Availability of required technical skills and technology (IMS) transfer
- **SO3** # of countries adapting and/or utilizing the KIX hub to inform policy formulation and implementation (by location)



- Key intervention 4: Build capacity for MEL among MoE staff

MEL Plan Roles and Responsibilities

- Producing Progress Reports and Annual Program
 Implementation Reports the totality of the outputs and outcomes produced by the KIX.
- Coordinating the processing, analysis, and dissemination of data/information generated by different member states.
- Meeting data requirement by other agencies including IDRC.
- Management and coordination among member states for learning and systems strengthening.
- Carrying out routine KIX Review involving stakeholders including the member states.
