### Outcome 1

Duty-bearers improve implementation of ATI laws/policies by effectively monitoring and reporting on SDG 16.10.2 and taking necessary follow-up action to strengthen governmental practices that promote access to information

### Output 2

SDG 16.10.2 reports produced by target countries at national level and used for global purposes, including in UN Secretary-General Report through UNESCO and in international fora

# Key activities



Institutionalize and formalize monitoring and reporting mechanisms



Organize capacity-building workshops to provide technical support and policy advice to duty-bearers on improving monitoring of SDG 16.10.2



Conduct activities with duty-bearers to track progress of their reporting on SDG 16.10.2, collect and analyse data, as well as to follow-up to recommendations of monitoring and reporting exercises



Train media outlets in investigative journalism and set up media partnerships, particularly applied to monitoring progress towards SDG issues in general and SDG 16.10.2 in particular



Conduct visibility and awareness-raising events, and highlevel discussions at national and global levels on the information collected through monitoring and reporting exercises



Integrate data from national reports into UNESCO/IPDC reports on SDG 16.10.2, and disseminate findings of reports at national and global levels

Main: Duty bearers (national and local governments)
Secondary: Right holders (CSOs, journalists and media organizations)

End beneficiaries: groups benefiting most from achieving the SDGs

## Implementation strategy

\*General implementation strategy -- the order of some activities may be adapted by respective UNESCO field offices, depending on specific needs and national particularities. Some activities may also take place in parallel.

### Integrate data from national reports into UNESCO/IPDC reports on SDG 16.10.2 and disseminate findings

Integration of findings at national level by the IPDC for the global reporting (é.g. UN Secretary-General Report, ÌPĎC Council, etc), as well as for World Trends Report and SDG16 thematic reports.

**Conduct visibility and** awareness-raising events and high-level discussions at national and global levels

Public awareness efforts on ATI issues and findings from reporting and monitoring exercises including through UN High-Level Political Forum on SDGs, the International Day for Universal Access to Information, other SDG conferences and IPDC statutory meetings.

#### Institutionalize and formalize monitoring and reporting mechanisms

Sensitization meetings with the government to appoint focal point(s) and/or establish a working group on SDG 16.10.2, and to promote the use of UNESCO's monitoring and reporting instruments to track progress towards access to information.



# workshops to provide technical support and policy advice

Training on UNESCO's instruments and SDGs targeted at Information Commissioner(s) or equivalent function, relevant ministries and government officials, including the national agency responsible for SDGs/ Voluntary National Review.

**Conduct activities** with duty-bearers to track progress of their reporting on SDG 16.10.2

Follow-up activities to ensure the monitoring and reporting are taking place; formulation of recommendations stemming from the monitoring and reporting exercises, inlcuding on integrating UNESCO's instruments into national SDGs mechanisms and/or action plans.

Train media outlets in investigative journalism and set up media partnerships

Workshop(s) to strengthen the capacity of journalists, particularly applied to monitoring progress towards SDG issues in general and SDG 16.10.2 in particular; animate partnership schemes to ensure followup coverage of issues by participating media outlets.

### Follow up on recommendations and action plans

Follow-ups on recommendations stemming from monitoring and reporting exercises to strengthen governmental practices.
