CONCEPT NOTE

Meetings on 16 and 26 October 2020

The Technical Cooperation Group (TCG) Secretariat and the chair of the TCG working group on data on teachers' personal data, Mr Robert Rakocevic, are pleased to convene you to two meetings for the working group:

- Meeting 1 on Friday 16 October 2020 at 12:30pm GMT (2:30pm Paris time (CEST))
- Meeting 2 on Monday 26 October 2020 at 12:30pm GMT (2:30pm Paris time (CEST))

These meetings will be an occasion to introduce the members of the groups to each other and engage in a collaboration and exchanges pertaining to the methodological aspects and use of teachers' data. The meetings will precede the TCG 7th Meeting on 27-29 October, during which the working group will be presenting to the members their progress, challenges, and work plan for 2020-2021.

Various indicators related to teachers require further methodological developments, including on issues related to definitional issues such as what is a qualified and a trained teacher. A tentative set of indicators and priorities have been referred in the working group Terms of References (ToRs):

Indicator priorities as referenced in the ToRs:

- 4.c.1 4.c.4 on trained and qualified teachers
- 4.c.5 on teacher salaries
- 4.c.6 on teacher attrition
- 4.c.7 on in-service training

In 2020, the COVID-19 pandemic has presented itself as a tremendous challenge over the recent months and will have a critical impact over the months to come, as challenge but also as an opportunity for statistical units to optimize the use of education data. An immediate obstacle relates to how schools, teachers, students and their parents/caregivers, and others have had to navigate the abrupt changes brought by the crisis. National statistical planning units have had to respond and ensure the continuity of existing data collection programmes, as well as new data needs to better respond to the pandemic, often adopting innovative approaches or resorting to alternative data sources.
