### **Prof. Eduardo Bertoni** Instituto Interamericano de Derechos Humanos

Eduardo Bertoni is Alternate Representative of the Regional Office for South America at the Inter-American Institute of Human Rights (IIDH). Former Director of the Agency for Access to Public Information and of the National Directorate for the Protection of Personal Data, Argentina. Founder of the Centre for Studies on Freedom of Expression and Access to Information (CELE) of the Faculty of Law of the University of Palermo. Former Executive Director of the Due Process of Law Foundation (DPLF) until May 2009. Between 2002-2005, Special Rapporteur for Freedom of Expression of the Inter-American Commission on Human Rights (IACHR) at the Organization of American States (OAS).

Eduardo is a lawyer of Argentinean nationality, a graduate of the University of Buenos Aires, a former fellow of the Human Rights Institute at Columbia Law School in New York and the National Endowment for Democracy. He holds a Master's degree in International Politics from George Washington University, and a PhD from the Buenos Aires University. He has taught undergraduate and graduate courses, including "Human Rights & Internet" and "Cyberspace and Crime".



## **Cristian Taboada** Organization of American States (OAS)

Cristian Gabriel Taboada is a lawyer, graduated from the University of Buenos Aires in Argentina. He has an M.A. degree in International Relations, with a specialization in International Politics and Security, from the Torcuato Di Tella University in Buenos Aires and The Paul Nitze School of Advance International Studies (SAIS) -Johns Hopkins University, in Washington, D.C. After practicing as a lawyer in the city of Buenos Aires, he has worked in the OAS Department of Public Security where he holds the position of Chief of the Security and Justice Section, since 2014.

In 2017, he received his postgraduate degree in Security Intelligence from the University of the South of Santa Catarina (Unisul). He began his career as a journalist in Brazil in 2003, working in print media, government agencies and digital media. In 2010, he was awarded the title of police officer of the Civil Police of Paraná (PCPR) and served in the Maringá Branch of the PCPR from 2011 to 2014. Mr. Nunes de Góes worked in the Intelligence Agency from 2014 to 2018, and in the State Narcotics Division in 2018.

Since January 2019, he is the coordinator of the PCPR Press Office and the PCPR Community Relations Office. Currently, he is also a professor of the subject of Communication and Media for the Postgraduate Course in Criminal Sciences of the Judicial Police, at the School of the PCPR. Mr. Nunes de Góes is also the creator of the Press Orientation Course for Acting in Armed Conflict Zones.



# Brigadier General Yackeline Navarro Ordoñez

Executive Directorate of the Police Education Internalization Network (RINEP) / National Police of Colombia

Brigadier General Yackeline Navarro Ordoñez began her professional career as a police administrator in 1992, after graduating from the "General Francisco de Paula Santander" Police Cadet School. She has held different positions and functions in departments such as Atlántico, Meta, Antioquia, and cities such as Medellín and Bogotá, which has allowed her to learn about the problems of each region and thus identify opportunities to strengthen the police service and optimise institutional capacities.

Thanks to his leadership and academic training, he has promoted important projects at the "Gonzalo Jiménez de Quesada" School for Non-Commissioned Officers and Executive Level, the "Miguel Antonio Lleras Pizarro" School of Higher Police Studies, the "IT. Maritza Bonilla Ruiz", the Criminal Investigation School "TC. Elkin Molina Aldana", and in her time at the Police Cadet School "General Francisco de Paula Santander", as company commander and later as deputy director, all framed in one of the main institutional values, discipline.
