**Section 3: Steps the Member State has taken to consider the specific risks faced by women journalists in the exercise of their work**

January 2020, MoI with UNESCO agreed to recruit 12 women police officers to work in the Special Investigation Unit on Crimes against the journalists. The special women officers' team will deal with the Female journalist's issues and complains. UNESCO will train them on who to respond to female journalists issues.

*Example:*

*CMC, MoI and UNESCO has convened a round tables and workshops to work with civil society organizations on training for local Female journalists, on the safety of women journalists on and offline.*
