# 50 YEARS IN THE SERVICE OF CULTURAL OBJECTS

The UNESCO 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property turns 50 years!

The convention is now ratified by 140 countries and has raised awareness about the illegal trade in cultural objects. This digital seminar is organized by the National Museums of World Culture, the Swedish National Heritage Board and The Swedish National Commission for UNESCO. Confirmed speakers and organizations are Swedish Minister

of Culture Ms Amanda Lind, UNESCO's Assistant Director-General of Culture Mr Ernesto Ottone Ramirez, Interpol, the Swedish Police and many more. The Swedish UNESCO Prize will be awarded during the seminar. It goes to cultural heritage journalist Ms Khazar Fatemi for her documentary series Culture in the Danger Zone, which with its personal appeal has spread knowledge about the crucial role of global cultural heritage in identity creation and shown that ancient cultural objects are not just objects but stories about people and communities.
