Geachte heer, mevrouw,

De Vlaamse Traditionele Sporten vzw (VlaS, ° 1988) is een koepelorganisatie in Vlaanderen - België voor tal van traditionele sporten en spelen. Sinds zijn oprichting heeft VlaS samen met de dragers en beoefenaars – die de raad van bestuur vormen – werkt gemaakt van de borging van dit erfgoed.

VlaS werkt daarbij samen met de Vlaamse overheid en andere sportfederaties en is vanaf het begin internationaal georiënteerd met de bedoeling een breed draagvlak te creëren voor traditionele sporten en spelen over de grenzen heen. Dit gebeurde onder meer door expertise uit te wisselen, deel te nemen aan festivals wereldwijd en internationale projecten op te zetten. Zo leidde VlaS het door de EU ondersteunde project ‘Strengthening European Traditionals Sports (SETS)’ - <http://www.europeantraditionalsportsforum.eu> (2015).

VlaS is ook betrokken geweest bij internationale netwerken zoals ETSGA en Tafisa. VlaS was bovendien een van de leidende partners in het Ludodiversity-programma dat in 2011 werd opgenomen in de UNESCO-lijst van goede praktijken van immaterieel cultureel erfgoed (Convention 2003).

VlaS was in de loop der jaren getuige van de werkwijze en de kracht van het Tocati-programma en de onderliggende filosofie waarin de lokale spel-gemeenschappen de centrale rol spelen en een bottom-up benadering belangrijk is. VlaS gaf advies bij de start van deze multinationale aanvraag in twee meetings te Brugge en Brussel en zal de Tocati-aanpak blijvend aanbevelen.

The Vlaamse Traditionele Sporten vzw (VlaS, ° 1988) is an umbrella organization in Flanders for more than twenty traditional sports. Since its creation VlaS worked on safeguarding of this heritage with the bearers and practitioners composing the board of directors.

In doing so, VlaS cooperates with the Flemish government and other sports federations and has been internationally oriented from the outset to create broad support for traditional sports and games across borders. It did so, among other things, by exchanging expertise, participating in festivals worldwide and setting up international projects, the most important being the EU supported project 'Strengthening European Traditionals Sports' (2015).

VlaS has also been engaged in international networks such as ETSGA and Tafisa. VlaS was furthermore one of the leading partners in the Ludodiversity Program that was included in the UNESCO list of good practices of ICH in 2009.

Over the years, VlaS has learned about the operation and power of the Tocati –program and its underlying philosophy where the ludic communities play the central role and a bottom up approach is important. VlaS gave advice to the development of the programme and will continue to encourage and promote the Tocati-way of safeguarding traditional games and sports.
