With the European Arca-Net (www.arca-net.info) places in Europe are promoted, where people can meet agrobiodiversity and learn about rare seeds and breeds and the traditions around the living heritage. Especially traditions and customs are collected within the project "Fundus Agri-Cultura Alpina". The term "Intangible Heritage" becomes more and more better known within the community of conservation of agrobiodiversity.

A lot of partners hesitate to prepare an application for inventories because of seemingly bureaucratic hurdles which are different from country to country within Europe. SAVE is in close contact to communities, museums, NGOs and also individual knowledge bearers of agrobiodiversity. a) SAVE Foundation continuously informs about the ICH during all its activities concerning the safeguarding of agrobiodiversity and promotes the importance of the intangible cultural heritage in context with agrobiodiversity within all its activities and publications like the quarterly SAVE eNewsletter, annual reports, project information and the SAVE facebook page. During the annual meetings of the SAVE network, ICH is also discussed in context with conservation of

agrobiodiversity. This promotion of ICH is an ongoing process.

- b) As a member of expert groups for the implementation of the Nagoya Protocol regulations within the EU regulations and its implementation (Guidance document on the scope of application and core obligations of Regulation (EU) No 511/2014, access and benefit sharing, participatory process on Genetic Resources in Agriculture, EU consultations) SAVE forces discussions especially on the term and meaning of "Traditional Knowledge" which is closely connected to ICH, mentioned in all related regulations and guidelines on genetic resources in agriculture, but which is not defined exactly. Additionally within consultancies and participation in different Horizon 2020 projects, SAVE promotes ICH in context with agrobiodiversity like http://dynaversity.eu/ or www.genresbridge.eu/.
- c) In presentations and at conferences, SAVE includes the topic intangible cultural heritage regulary. Also on facebook and in the quarterly newsletter, the SAVE eNews, ICH is mentioned and explained repeatedly.
- **B.7.** Describe your organization's involvement in measures to ensure greater recognition of, respect for and enhancement of ICH, in particular those referred to in Article 14, ODs 105 to 109 and OD 155:
 - a. educational, awareness-raising and information programmes aimed at the general public, in particular young people;

Within the SAVE activities, like the Fundus Agri-Cultura Alpina or the "Inforama Wild Fruit" aims to become

- a) A public science "self-running" knowledge database for agrobiodiversity in the Alpine Region. Several media campaigns, meetings and personal discussions motivate people to participate in the collection of traditional knowledge.
- b) Guided tours, workshops and trainings will be offered within the wild fruit project "Inforama Wild Fruit".
- c) Besides its activities on the ground, SAVE Foundation is also involved in the drawing up of EU policies and recommendations. As an expert NGO on agrobiodiversity activities in Europe, SAVE has provided several statements and expertises on the implementation of the Nagoya Protocol and "access and benefit sharing" on EU level. Especially the term "traditional knowledge" which is closely connected to ICH is a focus of the statements of SAVE foundation which can be seen e.g. in the EU "preparatory action on EU plant and animal genetic resources".
- d) ICH is not yet very well known in the public. Therefore SAVE includes this topic in all its activities. Capacity building takes places nearly throughout all activities of SAVE Foundation including the annual meetings, where intangible heritage and its practical significance for the conservation of agrobiodiversity and its traditions are highlighted.
- e) Within the European Arca-Net (www.arca-net.info) more than 600 places throughout Europe are described where agrobiodiversity can be experienced by the public life at farm animals and cultural plant varieties including traditions, cultural tangible and intangible heritage in agriculture. This information platform for the public is enhanced and updated continuously.

SAVE Foundation cooperates with European stakeholders for the conservation of agrobiodiversity and traditional agro-ecosystems in all its activities. Farmers are fully included as well as communities and science. Currently there are 25 partner organisations in 16 European countries and 2 European regions. Additional, there are several individuals included within the SAVE network e.g. through the board of directors (12 persons/11 countries) and other SAVE bodies.

Fundus Agri-Cultura Alpina (https://fundus-agricultura.wiki/) is a project to collect traditional agricultural knowledge in the Alps especially through public science. SAVE invited all interested individuals and groups to collect their special traditional knowledge in agriculture as well as the expression of this. Concerning ICH, SAVE is in contact with regional governments and regional institutions like the Association of Alpine States (Arge Alp). In collaboration with partners from Berne, Switzerland, the french speaking part of the Alps will be included from 2021 on.

To support the growing, use, traditions and knowledge of wild fruits a project to collect species and varieties of wild fruits in the field (in Switzerland) and on an internet plarform (www.wildobst.info) the "Inforama Wild Fruits" was launched.
