**B.1.** Describe your organization's participation in State efforts to develop and implement measures to strengthen institutional capacities for safeguarding intangible cultural heritage (ICH) (Article 13 and Operational Directive (OD) 154), e.g. in the drafting of ICH-related policies or legislation, in the establishment of national ICH committees or in other government-led processes.

Our oganisisation the Organisation facilitates the state efforts to document and safeguard ICH as well as to enhance and transmit ICH through education. More precisely, the Organisation's work focuses on traditional dance, music, costume and film. In this capacity, our recent activities include:

- National Inventory of ICH: Provision of information for the element Cyprus traditional Dancing, inscribed on the National Inventory of Intangible Cultural Heritage. Further to the description of the element, we have also provided detailed report of all the activities implemented for the promotion and safeguarding of this element since our establishment. (collection of relevant material, exhibitions, workshops, conferences and other initiatives aimed at the safeguarding and transmission of the traditional dance and music of Cyprus).
- ICH and Education: members of our Organisation collaborate closely with the Ministry of EducationCSY to raise awareness on ICH through education (i. facilitators in Museum Education Programmes of the Ministry ii. Coordinators of educational interactive workshops, such as "Visiting Evthalias Mansion", approved by the Ministry which introduces elements of Traditional dance, Music, Costume and story-telling of Cyprus iii. Creators of content, such as a mobile exhibition on the topic of traditional dance and music, to be hosted at schools.
- Capacity-building activities on ICH: Contribution to the implementation of the programme "Global Citizenhsip and Heritage Education" (Cyprus National Commission for UNESCO and ASPnet Cyprus network) as well as to the preparation of a publication on the same topic. Members of the Organisation participated as trainers in a capacity-building seminar for heritage education, targeting ASPnet teachers, organised by the Cyprus National Commission for UNESCO and the Cyprus Pedagogical Institute (Ministry of EducationCSY).

The action plan of our Organisation is supported by government stakeholders (Ministry of Education, Culture, Sports and Youth, Cyprus National Commission for UNESCO) and implemented in collaboration with local authorities (municipalities or community councils) and the private sector (A.G.Leventis Foundation, Leventis Municipal Museum of Nicosia, Nicosia Tourism Board). The Cultural Services of the Ministry of Education, Culture, Sports and Youth have launched a funding programme aimed at the safeguarding of ICH and traditional cultural expressions, through which our Organisation receives subsidies for the implementation of its annual activities that contribute to the objectives of the programme (documentation and

transmission of ICH, networking and exchange of best practices at national and international level, organisation of conferences and workshops, training opportunities, actions for youth).

We have not yet participated in the preparation of a nomination for any of the Lists. Although Politistiko Ergastiri contributes, through its activities, to the implementation of safeguarding measures of elements already inscribed on the Representative List and the National Inventory of ICH (such as: Tsiattista poetic duelling, Cyprus Traditional Dances, Cyprus Traditional Wedding Customs, Shadow Theatre - Karagiozis, Maxilles Lysou, Folk Stories and Myths),

The documentation regarding the measures implemented by our Organisation for the above is available to interested parties and could be used for reporting on the status of viability of the elements inscribed on the Lists.

Politistiko Ergastiri has been documenting <u>traditional dance</u>, music and other related customs since 1990, collecting relevant data. The information collected is examined carefully and used to transfer knowledge to younger members of our organisation. Dance is taught using the recorded material and then performed. The process of documentation is based on on-site visits, interviews and recording of individuals. To achieve this we cooperate with members of the families of the bearers of intangible heritage (e.g. dancer) and their community, to put these into context. The cooperation does not end with the recording, and where possible, the bearer is hosted in workshops, performances, speeches, seminars, trainings, in order to promote intergenerational dialogue and maintain the direct contact between experienced practitioners and new apprentices.

Politistiko Ergastiri has created a small inventory of gathered information in the form of video and documents which is available to its members, mostly for the purpose of knowledge transmission regarding. Cyprus dance and music.

In addition we have recently created a publication referring to the material gathered and its transmission.

Focused on our main topic, dance, music and song, we are actively developing structures that could host and promote activities aimed at the safeguarding but mostly to the implementation of activities and methodologies that have an impact on groups and individuals and focus on transmission of Intangible cultural heritage as a living heritage, not in a freezed form or as as a museum item. Our latest large performances "Terpsihori" 2018 and "Anadromi" 2020 have been serving our vision of linking the past and the present, through traditional music and dance, considering the current needs of people. The performance was perceived as a journey through time with music showing the links and the continuity. Our performances are not simply an exhibition of ability but a process of exchange with the audience, raising questions, discussions, awareness on ICH, which is very much alive in everyday life. Further to the above:

#### a. Promoting the function of ICH in society

As a priority, our organisation offers the premises and the facilities of our cultural centre (a traditional renovated house) to activities that promote cultural heritage elements. We are open in collaborating and supporting either individuals or groups supporting thus members of society in the promotion of ICH awareness. Its philosophy is characterized by open participation, acceptance and coexistence of people of all ages, abilities and roles, through dance, song and music which are the elements that connect participants. The idea is that dancing and its integral elements of music, song, costume (horostasi), is seen as an entity, palpating the links between the past, present and future, leaving traces in an attempt to discover, interpret and promote our cultural heritage.

- Politistiko was invited to <u>TEDxNicosia</u> to present its approach to traditional dance and music and therefore emphasising the traces of ICH to our days.

#### b. Fostering scientific, technical and artistic studies with a view to effective safeguarding

- cooperation with dance teachers, who have developed their knowledge on experience within our organisation, thus promoting networking and capacity building.
- establishment of a group song workshop, which meets every week and works on the transmission and interpretation of traditional songs under the guidance of a distinguished musician (Elena Xyda).
- support to the traditional orchestra "Tropos" ( $T\rho \delta \pi \sigma \zeta$ ), led by Michalis Kouloumis , a distinguished musician in his field (researcher, teacher, composer, performer). This group focuses on researching, performing and transmitting traditional music of Cyprus.
- -we host, researchers/musicians/dancers from Cyprus and Greece who share their findings and knowledge in set seminars and workshops directly with the public related particularly to traditional dancing

Our main objective is transmission of knowledge, attitudes and skills for the safeguarding of ICHthrough non-formal and informal education, activities in communities and performances for a broad public. In this respect, we organise on a regular basis open discussions to exchange of knowledge and ideas, we offer expertise to individuals interested and contribute in education and capacity building are oftenly organised.

#### Points a. and b.

#### ICH and Education - (schools/families)

Implementation of an **educational interactive workshop** called <u>"Visiting Evthalias Mansion"</u> which introduces elements of Traditional dance, Music, Costume and story telling of Cyprus. The educational program is approved by the Ministry of Education and is visited by school classrooms and families.

Implementation of an **educational program** called "**Let me tell you as story**" which introduces the structure of story telling and provides the opportunity to children of young age to identify the elements of a traditional tale, story and create their own.

- **-Creation of an exhibition** with the topic: traditional dance and music and how it can be transmitted, the content, its topics. The exhibition is movable and can be exhibited in schools. **-performances** with a topic which transmit a particular topic related with ICH elements
- **-publications** regarding the safeguarding of cultural heritage
- -weekly meetings not excluding but including presentations 2 -3 time a year following annual custom calendar. eg. local celebrations, christmas, easter

#### ICH and International activities

An example of our international activities is a project called <u>"Echoes of the City" (Living history in Museums</u>) The project had both a local and international implementation. The methodology allows museums, municipalities, local authorities, informal groups or even neighbourhood to be able to investigate their local heritage and share it with the public in an interactive and educational way. There has been an effort of creating a Good Practice guide that will be transferable to various groups and locations.

Our activities are based on non-formal process, personal pace, development, program adjusted to needs of participants,

#### ICH and places

Our organisation is situated in a renovated building which is declared as Cultural Heritage Building. This allows us to promoting the use of history. The building has been incorporated within the educational workshop for students called ""Visiting Evthalias Mansion"

- Politistiko Ergastiri has been involved in several European mobility projects, either by hosting or participating. The topics are related to youth and their personal development. In all projects, Cultural heritage elements such as music, dance, theatre were incorporated in the programmes, either as a means to achieve other objectives or as elements in the core of the activities planned. All projects contribute in networking with partners at european level and in improving our methods through exchange of knowledge and capacities. Our recent projects include, funded by the EU include: "Vibes of Life", as implemented between [2013-2015] hosted more than 200 young persons with a focus to dance and music.
- "Echoes of the City" was dedicated to the discovering of local heritage through interactive walks and involved participants from 6 different European countries. Both projects created a network of cultural and youth organisations supporting each other in the implementation of such projects.

Lately (January 2021) with the cooperation o CIFEJ (<a href="https://www.cifej.com/#">https://www.cifej.com/#</a>) we have organised an online seminar with the title Cinema in Schools, promoting Media literacy with the cooperation with EKOME UNESCO MIL Alliance co-Secretary General.

Our activities formulated under the above topics, contribute in the enhancement and interconnectedness of these elements. At the core of our work lies the philosophy of sharing knowledge, attitudes, skills as well as encouraging participatory approaches in an inclusive way.

We are always open to ideas, and persons willing to interact, create, implement projects under the mentioned topics are linked with each other.

Our organisation has been involved in international educational projects since 2007. Under the Youth program Youth in Action, later Erasmus plus and European solidarity corps. It has also implemented a project under The Culture Program in collaboration with other European countries. Our activities range from youth exchanges and trainings to long term cultural programs, coordinating-hosting-sending volunteers from and to Cyprus. It has been actively supporting the Cyprus National Agency in implementing training seminars targetingYouth, Personal Development, active Citizenship and Culture. Members of our organisation have been trained and implementing successfully both the organisational aspects and the content aspects with an emphasis on learning objectives. As an organisation we have created an international network of organisations and persons (trainers/eductioners/managers) which support each other in the implementation of such projects.

Specifically, linked to cultural heritage we have created and implemented a project called <u>"Echoes of the City" (Living history in Museums)</u> The project had both a local and international implementation. As a good practice it has been proposed as a KA2 Educational project to be implemented in 4 European cities. Its transferability as a good practice will allow museums, municipalities, local authorities, informal groups or even neighbourhood to be able to investigate their local heritage and share it with the public in an interactive and educational way. The whole implementation was a concept developed by our organisation and shared with partners.

We would be willing and able to undertake any international task under Unesco if asked.
