With this award, the community radio sector of Nepal has completed a full circle. Therefore I would like to receive this honor on behalf of the entire community radio sector of Nepal including all those that continue to work hard for its promotion.

As you all know, community radio is the voice of the voiceless and marginalized. UNESCO's support to this sector has given amplitude and strength to the marginalized million. I am proud to inform you that today community radio in Nepal reaches 85% of Nepal's population of 27 million. Thanks to your support that this has been possible.

Today's award enhances our motivation, commitment and strength to keep marching on, to ensure that the poorest of the poor, the women, the physically challenged, the indigenous people, as well as the young and the elderly can use the airwaves for improving their lives for their today as well as their tomorrow. To have a world body such as UNESCO and INGOs such as Free Voice and Open Society Institute as supporters and allies means a lot to us, to say the least.

Lastly, I would also like to thank the World Association of Community Radio Broadcasters, AMARC for nominating CRSC/NEFEJ for the award. As for the award, I would like to inform this respected assembly that CRSC/NEFEJ has decided to use the prize money to set up a trust fund to generate resources to award organizations or individuals working on community communications in my country.
