Ankara Club Association was established to protect and develop any type of material and cultural heritage of Capital Ankara. It also has tremendous and critical responsibility to follow closely current problems of Ankara.

Ankara Club Association conducts scientific, cultural and artistic events at international level in order to develop and introduce Capital Ankara in terms of its historical and cultural values, human capital, economical and in other areas.

One of the main aims of Ankara Club is to keep and maintain Seymen Tradition.

Seymen tradition extends to the 6th century Oghuz Turks. Oguz caravans, who try to cope with the natural conditions in Central Asia, are responsible for protecting the caravan against any attack while the migrants move from one place to another.

Ahi Community which was critical social power in the Anatolia of 13th and 14th centuries and Ankara Ahi State, a state which was founded by Ahis in Ankara which was governed by a type of "republican government" had a great impact of institutionalization of Seymen Tradition in Anatolia.

Bacierens were women branch of Ahis and Seymens. One of the aims Ankara Club is also keep and maintain Bacieren tradition. Our Association aims to research develop and maintain this rooted tradition, particularly folk music, folk dances, in any social-cultural dimensions and transfer the these historical and cultural values to next generations, and we are continuing with our activities intensely within the scope of this purpose.

Ankara Club Seymens and Bacierens hold the ceremonies and memorial programs that are organized in various special days of Ankara, such as anniversary of December 27, 1919 which is the arrival of Mustafa Kemal Atatürk to Ankara, October 13, 1923 which is the declaration of Ankara as the capital city of Turkey and October 5, 1922 which is the declaration of Atatürk as a Countryman of Ankara etc. They also participate to national holidays, international events several activities, memorial days and cultural events that are organized for public benefit.

The historical and cultural heritage of the Seymen and Bacieren traditions is lived by the Ankara Club.
