The iTaukei Trust Fund Board (TTFB) was established under an act of parliament on 4<sup>th</sup> November 2004, which superceded its registration as a Deed of Trust on 18 January 2002. It has been in existence for over 16 years.

#### 5. Objectives of the organization

The iTaukei Trust Fund Board was established by the Fiji government to foster the advancement of indigenous Fijians and Rotumans by promoting initiatives that will better their standard of living and enhance appropriate cultural traditions and values.

Safeguarding of intangible cultural heritage has been a national priority since Fiji's ratification of the 2003 Convention of Intangible Cultural Heritage. However, national cultural programs are hampered by the lack of resources and local expertise in culture and heritage. TTFB contributes towards boosting the capacity of Fiji's cultural sector through the provision of scholarships, specialist services in language, culture and heritage, and financial assistance. It is therefore mandated to 'provide funding for the undertaking, promotion and sponsoring of programmes on Fijian language, culture and the study of ethno-history and ethno-geography'.

As indigenous Fijians are being absorbed into the modern world, there is a danger of losing their language, culture and identity. To support the preservation and safeguarding of intangible cultural heritage, TTFB is mandated 'to develop and sponsor research into languages, art and culture of indigenous Fijians and Rotumans for the better understanding and preservation of their heritage'.

TTFB also recorgnises the need to provide capacity building programs for indigenous Fijian leaders to excel in leadership, resource management and entrepreneurship. The purpose is to equip leaders with essential insights, knowledge and skills necessary in this fast changing economy. Hence, another objective of the iTaukei Trust Fund Board is to "help develop the management, leadership and entrepreneurial skills of the indigenous Fijians and Rotumans".

Objectives also include 'any other purpose approved by the Board and beneficial to the indigenous Fijians and Rotumans'. TTFB embraces sustainable development goals while at the same time ensure the safeguarding of intangible cultural heritage.

The iTaukei Trust Fund Board supports and promotes the safeguarding of intangible cultural heritage as guided by the principles enshrined in the 'iTaukei Trust Fund Act'. The following are descriptions of recent and ongoing projects/activities sponsored and implemented by TTFB:

The Cultural Centre project is an initiative to promote, safeguard and celebrate the living cultural heritage of indigenous Fijians and Rotumans through temporary & permanent exhibitions, publications, interactive media, community outreach events, workshops etc. A draft framework has been developed by a selected group of local and overseas professionals representing TTFB stakeholders and beneficiaries. Language and culture programs are currently being implemented in preparation for the Cultural Centre.

Recently in July 2017, TTFB was engaged in the development and assemblage of a temporary exhibition called 'Kamunaga: a story of the tabua', which was hosted at the Fiji Museum, Suva. TTFB was invited to co-curate the exhibition in partnership with the Fiji Museum and the Sainsbury Research Unit in UK. 'Tabua' or whales tooth is regarded as the most prestigious valuable used in ceremonies of exchange between kin groups in Fijian society. It is also regarded as the greatest of all valuables signifying the abundance of 'iyau' or wealth.

In conjunction with the Cultural Centre project, TTFB has also implemented in 2017 a Vanua Fieldworkers Programme, which involves researchers across the 14 provinces of Fiji, to collect, record and transmit distinctive aspects of ICH. This program will tap into existing government resources such as the Cultural Mapping Program, and collate information for research, exhibition and educational purposes.

TTFB is also established as a Publishing House for the production of various publications in both the English and Fijian languages. Publications include books, dvds, primary and secondary school texts, reading and teaching materials, pertaining to indigenous knowledge and cultural expressions. The purpose is to contribute to existing literatures on Fijian language, art, culture and heritage, support the Curriculum Advisory Unit of the Ministry of Education, and transmit ICH to the younger generations.

In February 2018, TTFB organised and hosted the first ever museum education workshop for Commonwealth countries in the Pacific, in partnership with the Commonwealth Association of Museums, ICOM - ICTOP, and the Fiji Museum. The workshop attracted a diverse range of stakeholder groups with the aim of developing museum or cultural education programs, to be integrated in the national curriculum.

TTFB supports the Fijian Language Studies Programme at the University of the South Pacific, offering courses in oral literature, linguistics and the Fijian culture. It also sponsors cohorts of Fijian teachers and professionals to undertake the programme and attain a Diploma in Pacific Vernacular Studies.

TTFB was also very crucial in spearheading the development of a Traditional Leadership and Good Governance curriculum, that is now offered at an accredited academic institution in Fiji. The program is designed for successors of the chiefly title across the 14 provinces of Fiji. To date, TTFB takes lead role in sponsoring and coordinating the delivery of the program.

TTFB also recognises the need to develop training and learning materials of diaspora focus. To date, the organisation is working towards the development of an Edu Kit/Training Manual particularly for the UK Fijian Communities, to learn and better understand their language, culture and identity.

TTFB comprises 8 personnel (including the Chief Executive Officer) from diverse disciplinary backgrounds in relation to the investment and culture and heritage portfolios. However, the following members of the organization have the competence and expertise in the domain of intangible cultural heritage:

Dr. Apolonia Tamata is a PhD graduate in Linguistics, with years of professional experience in teaching, translation, policy development and culture and heritage management. She served as an academic and lecturer of the Fijian language studies programme at USP and since 2009, she has worked as a Senior Culture & Heritage Specialist/Senior Program Analyst, responsible for TTFB's language and culture programmes.

Mrs. Unaisi Manulevu holds a Master of Arts degree in the Arts of Africa, Oceania and the Americas from the UK, and a Bachelor of Social Sciences in Anthropology from NZ. She has worked for more than 10 years in the cultural sector and is currently serving as the officer responsible for the Cultural Centre project.

Mr. Mika Sela, holds a post graduate diploma in Linguistics with years of experience in the teaching of English and Fijian languages. He specializes in project monitoring and evaluation, and the management and preservation of certain archaeological or cultural heritage sites.

TTFB has sponsored and developed programmes through effective consultations and collaborations with stakeholders, cultural authorities, local and diaspora Fijian communities:

1. TTFB's Publishing House has produced and published numerous resources such as books, DVDs, school texts, teaching materials etc. including the Fijian Monolingual Dictionary - a project that resulted from years of research on the Fijian language, culture and heritage. TTFB recognises the sustainable production of valuable resources and publications in maintaining and transmitting

#### ICH.

- 2. Training and workshops have been professionally developed for awareness, upskilling and capacity building, involving stakeholders, cultural practitioners and local communities. They include creative writing, leadership and good governance, cultural centre awareness, museum curatorship, active citizens, and the Fijian Vernacular Studies programme at the University of the South Pacific.
- 3. To contribute to the existing literature on Fijian arts, language and culture, researches are encouraged and supported by TTFB. Project staff and professional consultants with strong research skills and knowledge are often engaged in this pursuit to raise the standard of Fijian literatures, disseminate and promote the living cultural heritage of indigenous Fijians. Philosophical researches on significant heritage sites and funerary rites or 'somate' have been completed.
- 4. TTFB has experiences in curating language and cultural exhibitions, and in coordinating the Vanua Fieldworkers program for the development of the Cultural Centre project. These initiatives involve the engagement of local communities, artists and cultural practitioners to also carry out educational programs or cultural revival workshops for the transmission of ICH.
- 5. TTFB also contributes to the local arts sector through theatrical productions of Fijian culture and traditions, and revival of art and craft skills that are in danger of being lost. For example, the Rotuman fine mat weaving workshop was sponsored by TTFB in 2005 to revive and transmit inherent skills and knowledge to the younger generation.

Finally, consultancy advice and expertise are provided to cultural authorities, local and overseas researchers, and research institutions on matters pertaining to the Fijian language, art, culture and heritage.





## A DECREE TO AMEND THE FIJIANS TRUST FUND ACT TO MAKE NEW PROVISION FOR THE CONSTITUTION OF THE FIJIANS TRUST FUND BOARD

In exercise of the powers vested in me as Vice-President of the Republic of Fiji by virtue of the Office of the Vice-President and Succession Decree 2009 I hereby make the following Decree:

#### Part 1 - PRELIMINARY

Short title

1. This Decree may be cited as the Fijians Trust Fund Act (Amendment) Decree 2009.

#### Part 1-Preliminary

#### Short title

1. This Act may be cited as the Fijians Trust Fund Act

#### Interpretation

In this Act, unless the context otherwise requires—
 "beneficiaries" means persons or institutions that are beneficiaries of the Fund under section 5;

"BLV" means the Bose Levu Vakaturaga (Great Council of Chiefs) established under the Fijian Affairs Act;

"Board" means the Fijians Trust Fund Board established under section 7;

"Fijian Affairs Board" means the Fijian Affairs Board established under the Fijian Affairs Act;

"Fund" means the Fijians Trust Fund established under section 3.

#### Part 2—Establishment of Fijians Trust Fund and Board

#### Establishment of the Fund

3.—(1) This section establishes the Fijians Trust Fund consisting of—

- (a) trust property and retained earnings of the Fijians Trust Fund, an incorporated trust for charitable purposes registered on 18 January 2002;
- (b) amounts received by way of dividends and other income from investments of the capital of the Fund as authorized under this Act;
- (c) any amount appropriated by Parliament; or
- (d) any grant or donation to the Fund.
- (2) The Board must not transfer or assign to the BLV or any person any part of the Fund other than in accordance with this Act.
- (3) Income from the Fund may be applied for the purpose of meeting the operating expenses of the Fund and the Board, including all costs, charges and expenses incidental to the management of the Board or to the exercise of any power, duty or function of the Board.
  - (4) The Trustee Act does not apply to the Fund or the Board.

#### Purposes of the Fund

4. The purposes of the Fund are—

- (a) to provide financial independence and autonomy in relation to the operations and administration of the BLV;
- (b) to provide funding for the undertaking, promotion and sponsoring of programmes on Fijian and Rotuman languages, culture and the study of ethno-geography and ethno-history;
- to provide funding to help develop the management, leadership and entrepreneurial skills of indigenous Fijians and Rotumans;
- (d) to sponsor research into languages, art and culture of indigenous Fijians and Rotumans and the better understanding and preservation of their heritage;
- (e) any other purposes approved by the BLV as advantageous to the beneficiaries.

#### Beneficiaries of the Fund

5. The beneficiaries of the Fund are indigenous Fijians and Rotumans and their institutions, including the BLV, selected under guidelines determined by the BLV, and registered and issued with certificates as prescribed by regulation.

#### Application of Fund income

6. The Board must expend the net income from the Fund for the purposes of the Fund.

#### Establishment of the Board

- 7.—(1) This section establishes the Fijians Trust Fund Board.
  - (2) The Board is a body corporate with perpetual succession and a common

seal, which may acquire, hold or dispose of property, enter into contracts and sue and be sued in its corporate name.

- (3) The Board consists of 8 members to be appointed by the Minister including—
  - (a) 5 members nominated by the BLV;
  - (b) one member, who must be a legal practitioner registered under the Legal Practitioners Act 1997;
  - one member, who must be a chartered accountant in public practice registered under the Fiji Institute of Accountants Act;
  - (d) one member, who must be a person with suitable qualifications and work experience as an economist, professional manager, sociologist, historian or similar expertise.
- (4) Nominations made under subsection (3)(a) are not limited to members of the BLV and appointments made under subsection (3)(b), (c) and (d) are not limited to indigenous Fijians and Rotumans.
- (5) The Minister, after consultation with the BLV, shall designate a member of the Board as Chairperson of the Board.
- (6) Unless earlier removed in accordance with this Act, members are appointed for a term of 3 years and are eligible for re-appointment for one subsequent 3-year term.
- (7) A member of the Board may be removed from office for inability to perform the functions of a member, whether arising from infirmity of body or mind or any other cause, or for misbehaviour or for absence from 3 consecutive meetings of the Board without reasonable excuse, and may not otherwise be removed.

#### Functions of the Board

8.—(1) The functions of the Board are—

- (a) to invest the Fund, as the Board determines, in any investment approved by the Minister of Finance or of a kind authorized under the Trustee Act; and
- (b) after making provision for the expenses of administration, to expend the net income arising from the investments.
- (2) The Board may in respect of any moneys invested under subsection (1) vary, sell and transfer any such investments as may from time to time be necessary for the proper administration of the Fund.

#### Meetings of the Board

- 9.—(1) The Board must meet at least once every 3 months or upon the written request to the Chairperson by not less than 5 members.
- (2) In the absence of the Chairperson at a meeting, the members must appoint a temporary Chairperson to exercise the powers and function of the Chairperson for that meeting.
- (3) The quorum at a meeting of the Board consists of 4 members, not less than 3 of whom must be appointed under section 7(3) (a).
- (4) If there is an equality of votes on any question before the Board, the Chairperson shall have a casting vote.
- (5) The Board may take independent legal advice on any matter concerning the position of a member of the Board or on the administration of the Fund.
- (6) The Board may appoint one or more special purpose subcommittees of the Board to examine specific topics and report their findings to the full Board, and in the

performance of such examination, a subcommittee may recruit the assistance of professional and other advisors.

(7) The Board shall determine its own procedure.

#### Powers of the Board

- 10. The Board is empowered—
  - (a) to draw up for approval by the Fijian Affairs Board and subsequent endorsement by the BLV, an annual strategic plan and budget, and set performance objectives and implement and monitor performance under such plans and objectives;
  - (b) to determine the quantum of allocation of funds from the income of the capital of the Fund for beneficiaries selected by the BLV, in a manner and under terms and conditions that the Board considers to be in the best interests of the Fund and the recipient beneficiaries;
  - (c) to require beneficiaries to furnish any information in respect of funds to be allocated and may require an independent audit of the funds allocated;
  - (d) to terminate funding arrangements for any beneficiary upon non-compliance of any terms or conditions of the funds allocated;
  - (e) to pay from the income of the Fund any expenses, cost or expenditure, including legal and accounting fees, properly incurred in the discharge of its functions under the Act;
  - (f) to retain income in the Fund, after paying expenses, costs or expenditure, to be applied for the purposes of the Fund;
  - (g) to do all acts and things which the Board considers necessary or desirable and proper to further the purposes of the Fund and in the best interests of the beneficiaries.

#### Disclosure of interest

11. A member of the Board who has an interest in a matter to be discussed or determined by the Board must declare his interest and must not take part in any decision of the Board on the matter.

#### Allowances, fees and expenses

12. The members of the Board are entitled to allowances, fees and expenses as prescribed by the Minister.

#### Part 3—Management and Financial Provisions

#### Chief Executive Officer and other staff

13. The Board may appoint a Chief Executive Officer and other staff as it considers necessary for the proper and efficient carrying out of the functions of the Board.

#### Power to give directions

14. The Minister, on the recommendation of the Fijian Affairs Board, may give a general or special policy direction to the Fijians Trust Fund Board relating to the exercise of its functions under section  $\mathcal{S}(l)(b)$  and the Board must comply with the direction.

#### Power to borrow

15. The Board may, with the approval of the Minister of Finance, borrow any sums required by the Board to exercise its powers or carry out its functions and duties.

#### Accounts and audit

16.—(1) The Board must keep accounts and records of transactions of the Fund and

its operations and must prepare financial statements and accounts for each financial year.

(2) The accounts of the Board must be audited annually by an auditor who is a chartered accountant registered under the Fiji Institute of Accountants Act, and holds a certificate of public practice as required under section 36 of that Act and is approved by the Minister.

#### Annual report

- 17.—(1) The Board must in each year prepare a report on its activities and on the Fund, including its financial report, and submit the report to the Minister within 6 months from the end of the year to which the report relates.
- (2) The Minister must cause a copy of the annual report to be laid before each House of Parliament at the meeting of Parliament after the Minister receives the report.

#### Part 4-Miscellaneous

#### Protection from personal liability

18. A member of the Board or of a committee, the Chief Executive Officer, the Secretary to the Board or other staff member of the Board is not personally liable for any act or default done or omitted to be done in good faith under this Act and any sums of money, damages or costs which may be recovered against the member or staff member in respect of such an act or default are to be paid out of the Fund.

#### Termination

19. The Fijians Trust Fund incorporated in the Fiji Islands on 20 December 2001 under a Declaration of Trust and a Funding Deed registered with the Registrar of Deeds on 18 January 2002 is terminated.

#### Regulations

20. The Minister may make regulations to give effect to the provisions of this Act and in particular to provide for registration as beneficiaries and the issue of certificates and their content.

#### Transitional and savings

- 21.—(1) At the commencement of this Act, any property, rights, obligations or liabilities vested in or belonging to the Fijians Trust Fund incorporated in the Fiji Islands on 20 December 2001 is vested in or transferred to the Fund without conveyance, transfer or assignment to be held by the Fund for the purposes of the Fund.
- (2) At the commencement of this Act, the members of the Board of Trustees of the Fijians Trust Fund incorporated in the Fiji Islands on 20 December 2001 continue as if they had been appointed under this Act until their terms of office expire.
- (3) At the commencement of this Act, the Chief Executive Officer of the Fijians Trust Fund continues as if he had been appointed under this Act until his term of office expires.

#### Consequential amendment

22. Section 17 of the Income Tax Act is amended by substituting the full-stop at the end of paragraph (60) with a semi-colon and by adding the following paragraph—

"(61) the income of the Fijians Trust Fund.".


