Subject: Updating of the Official Correspondence Guide and launch of the Constituency Relationships Management (CRM)
Portal

Sir/Madam,

In order to improve the communication of the Organization with its official partners throughout the world, the Sector for Priority Africa and External Relations (PAX) periodically updates its data relating to national authorities responsible for UNESCO's fields of competence.

As you will recall, UNESCO has been working on implementation of the Constituency Relationships Management (CRM) tool designed to manage all contacts including National Commissions, Permanent Delegations, donors and partners, as well as to provide a centralized events management system.

The CRM, regularly updated by PAX, indicates the contact addresses of Member States, Associate Members, National Commissions for UNESCO and Permanent Delegations to UNESCO. It also contains guidelines on the language to be used in official correspondence, the transmission modalities and the preference of the Member States for receiving official correspondence electronically or by regular post (or both).

In addition, some of you have already participated in the pilot phase of the CRM Portal, created by UNESCO in order to improve the data sharing with its main stakeholders and allowing National Commission/Permanent Delegations to access to information related to official contacts and organizations. We are grateful for your participation and feedback for the new Portal.
