La Delegación Permanente de México ante la UNESCO saluda atentamente al Secretariado de la Convención para la salvaguardia del patrimonio cultural inmaterial 2003 y hace referencia a la *solicitud oficial* presentada por parte de la ONG *Desarrollo Gradual Directo A.C.*, el 14 de abril del presente año, para brindar servicios de consultoría al Comité Intergubernamental de la Convención de 2003, así como a la recomendación sometida por parte del Secretariado a la 16a. Sesión del Comité Intergubernamental de la Convención para la acreditación de la mencionada ONG.

Sobre el particular, las autoridades mexicanas, consideran pertinente manifestar ante el Secretariado de la Convención el desconcierto de México por la recomendación positiva para la acreditación de dicha ONG ante la Convención de 2003, así como respecto del proceso de revisión de esta petición.

En este sentido, se señalan a continuación diversas deficiencias observadas en el formulario ICH-09, así como en la documentación probatoria que fue remitida por Desarrollo Gradual Directo, A.C.:

1. El contenido del Formulario ICH-09 es deficiente en cuanto a la descripción exhaustiva de las actividades y proyectos que lleva a cabo la ONG y carece de la calidad lingüística requerida para este tipo de solicitudes.
2. De acuerdo con lo establecido en el punto 3 del Formulario ICH-09, la ONG indica que es activa también en África, de lo cual no se encontró evidencia ni mención específica.
3. De manera general, se puede afirmar que el tipo de actividades que lleva a cabo la ONG, si bien en algunos casos se vinculan con población mazahua del Estado de México, no guardan ninguna relación con el espíritu y objetivos de la Convención de 2003 para la Salvaguardia del Patrimonio Cultural Inmaterial, ni con el concepto del Patrimonio Cultural Inmaterial, lo cual es fundamental para aspirar a la acreditación como instancia consultiva.
4. Respecto al punto anterior, y con base en la documentación probatoria presentada, las actividades de la ONG pueden ser catalogadas prioritariamente como de asistencia social, en las que se incluyen temas como protección civil, trasplantes de órganos y violencia intrafamiliar que, adicionalmente a su nula vinculación con el Patrimonio Cultural Inmaterial, no se perciben como parte de un proyecto integral, sino como acciones aisladas.
5. En la revisión de la documentación probatoria de sus actividades, se incluyen constancias que dan cuenta de la asistencia de sus miembros a eventos y participación en cursos de muy diversa índole, lo cual de ninguna manera se puede tomar como constancia de las actividades sustantivas que lleva a cabo la ONG.
6. En la página 117 de la solicitud, se incluye una captura de pantalla que aparentemente da cuenta de la membresía de Desarrollo Gradual Directo, A.C., en la rama de ONG's del Departamento de Asuntos Económicos y Sociales de las Naciones Unidas (ECOSOC). Sin embargo, al hacer la búsqueda manual en dicha página web (<http://csonet.org/>) se descubrió con extrañeza que la ONG Desarrollo Gradual Directo, A.C. no se encuentra como parte de sus afiliados. Se adjunta imagen de evidencia, así como el listado de las ONG's de carácter consultivo que puede consultarse en <https://undocs.org/E/2019/INF/5>:

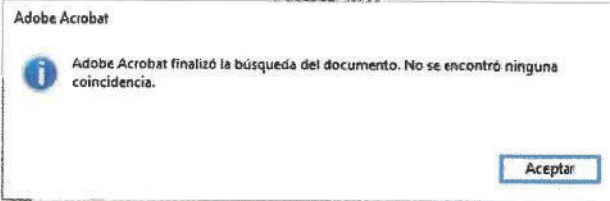

7. Finalmente, las cartas de apoyo de personas del pueblo mazahua que se incluyen en el expediente datan del año 2015, con lo cual no es posible establecer la vigencia de sus actividades.

Con base en estos hechos, se considera que la ONG Desarrollo Gradual Directo, A.C. no cumple con los criterios de elegibilidad establecidos en el Capítulo III.2 de las Directrices Operativas de la Convención de 2003.

Derivado de lo anterior, se transmite el pronunciamiento de México respecto a la ONG Desarrollo Gradual Directo, A.C., destacando la importancia de llevar a cabo procesos de revisión exhaustiva de este tipo de solicitudes de ONG, dado que pueden generar un antecedente para el ingreso de agentes que, lejos de contribuir al afianzamiento de la Convención, pongan en entredicho y tergiversen sus objetivos y espíritu.

La Delegación Permanente de México ante la UNESCO aprovecha la oportunidad para reiterar al Secretariado de la Convención de 2003, las seguridades de su más atenta y distinguida consideración.

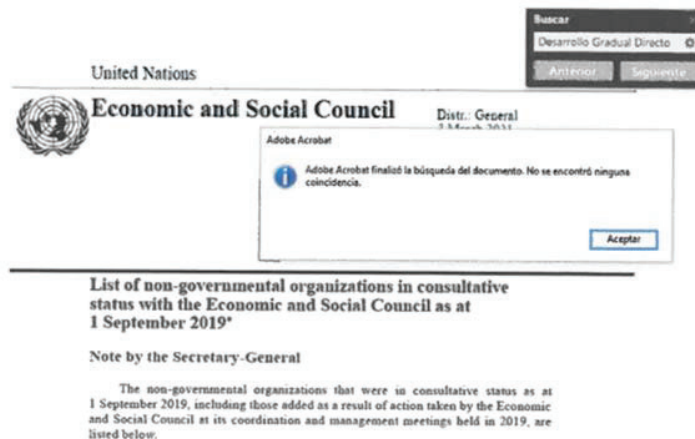
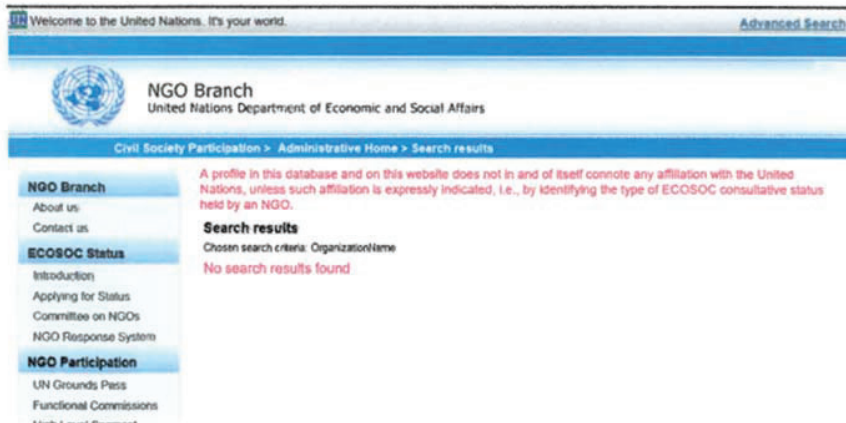

The Permanent Delegation of Mexico to UNESCO presents its compliments to the Secretariat of the 2003 Convention for the Safeguarding of the Intangible Cultural Heritage and writes in reference to the official request submitted by the NGO *Desarrollo Gradual Directo A.C.* (Direct Gradual Development), on 14 April 2021, to provide consultancy services to the Intergovernmental Committee of the 2003 Convention, and the recommendation submitted by the Secretariat to the Intergovernmental Committee of the Convention, at its sixteenth session, for the accreditation of said NGO.

In this regard, the Mexican authorities consider it pertinent to express to the Secretariat of the 2003 Convention Mexico's bewilderment at the positive recommendation made to the Intergovernmental Committee of the 2003 Convention for the accreditation of said NGO, and the review process of this request.

We have highlighted below several deficiencies observed in form ICH-09 and the supporting documentation submitted by *Desarrollo Gradual Directo, A.C.*

1. The content of form ICH-09 does not provide a comprehensive description of the activities and projects carried out by the NGO and lacks the linguistic quality required for this type of request.
2. According to the information provided in item 3 of form ICH-09, the NGO states that it is also active in Africa, of which no evidence or specific mention was found.
3. In general, it can be stated that the type of activities carried out by the NGO, although in some cases they are linked to the Mazahua population of the State of Mexico, do not have any relation with the spirit and objectives of the 2003 Convention for the Safeguarding of the Intangible Cultural Heritage, nor with the concept of intangible cultural heritage, which is essential to a request for accreditation as a consultative body.
4. With respect to the previous point and based on the evidentiary documentation presented, the NGO's activities can be classified mainly as social assistance, which includes matters such as civil protection, organ transplants and domestic violence and which, in addition to their lack of linkage with the intangible cultural heritage, cannot be considered as part of a comprehensive project, but rather as isolated actions.
5. Among the evidentiary documentation of the NGO's activities, there is evidence of the attendance of its members at events and participation in courses of a very diverse nature, which in no way can be considered as evidence of the substantive activities carried out by the NGO.
6. On page 117 of the request, a screenshot is included that apparently shows the membership of *Desarrollo Gradual Directo, A.C.* in the NGO branch of the United Nations Economic and Social Council (ECOSOC). However, upon doing a manual search on that web page (<http://csonet.org/>) it was discovered with surprise that the NGO *Desarrollo Gradual Directo, A.C.* is not listed as one of its affiliates. Below is evidence, in the form of a screenshot. In addition, a list of the NGOs in consultative status with the Economic and Social Council may be consulted at the following address: <https://undocs.org/E/2019/1NF/5>:



7. Lastly, the letters of support from the Mazahua people included in the file date from 2015. Consequently, it is not possible to establish the validity of its activities.

Based on these facts, it is considered that the NGO *Desarrollo Gradual Directo, A.C.* does not comply with the eligibility criteria set forth in Chapter III.2 of the Operational Directives for the Implementation of the Convention for the Safeguarding of the Intangible Cultural Heritage.

In the light of the above, Mexico states its view regarding the NGO *Desarrollo Gradual Directo, A.C.*, highlighting the importance of conducting exhaustive review processes on these types of NGO requests, given that they may generate a precedent for the accreditation of bodies that, far from contributing to the strengthening of the 2003 Convention, may call it into question and distort its objectives and spirit.

The Permanent Delegation of Mexico to UNESCO takes this opportunity to renew to the Secretariat of the 2003 Convention the assurances of its highest consideration.

La Délégation permanente du Mexique auprès de l'UNESCO présente ses compliments au Secrétariat de la Convention pour la sauvegarde du patrimoine culturel immatériel (2003) de l'UNESCO et fait référence à la *demande officielle* présentée par l'ONG *Desarrollo Gradual Directo A.C.*, le 14 avril de cette année, en vue de fournir des services de conseil au Comité intergouvernemental de la Convention de 2003, ainsi qu'à la recommandation présentée par le Secrétariat à la 16<sup>e</sup> session du Comité intergouvernemental de la Convention concernant l'accréditation de ladite ONG.

À cet égard, les autorités mexicaines considèrent qu'il est opportun de faire part au Secrétariat de la Convention de l'incompréhension du Mexique quant à la recommandation positive formulée pour l'accréditation de cette ONG auprès du Comité intergouvernemental de la Convention de 2003, ainsi qu'en ce qui concerne le processus d'examen de cette demande.

Voici quelques-unes des diverses lacunes identifiées dans le formulaire ICH-09, ainsi que dans les pièces justificatives qui ont été soumises par *Desarrollo Gradual Directo, A.C.* :

1. Le contenu du formulaire ICH-09 ne décrit pas de manière exhaustive les activités et les projets menés par l'ONG et ne présente pas la qualité linguistique requise pour ce type de demande.
2. Selon les informations fournies au point 3 du formulaire ICH-09, l'ONG indique qu'elle est également active en Afrique, ce pour quoi aucune preuve ou mention spécifique n'a été trouvée.
3. De manière générale, on peut affirmer que le type d'activités menées par l'ONG, bien qu'elles soient liées dans certains cas à la population mazahua de l'État de Mexico, n'ont aucun lien avec l'esprit et les objectifs de la Convention de 2003 pour la sauvegarde du patrimoine culturel immatériel, ni avec le concept de patrimoine culturel immatériel, ce qui est pourtant essentiel pour demander l'accréditation en tant qu'instance consultative.
4. En ce qui concerne le point précédent, et sur la base des pièces justificatives présentées, les activités de l'ONG peuvent être classées principalement dans la catégorie des activités d'assistance sociale, qui englobent des questions telles que la protection civile, les transplantations d'organes et la violence familiale et qui, outre leur lien inexistant avec le patrimoine culturel immatériel, ne peuvent être considérées comme faisant partie d'un projet global mais comme des actions isolées.
5. Parmi les pièces justificatives des activités de l'ONG figurent des preuves de la présence de ses membres à des événements et de leur participation à des cours de différents types, ce qui ne peut en aucun cas être considéré comme une preuve des activités de fond menées par l'ONG.

6. À la page 117 de la demande, une capture d'écran semble prouver l'appartenance de Desarrollo Gradual Directo, A.C. à la liste des ONG dotées du statut consultatif auprès du Conseil économique et social des Nations Unies (ECOSOC). Cependant, en effectuant une recherche manuelle sur le site Web du service (<http://csonet.org/>), on a découvert avec étonnement que l'ONG Desarrollo Gradual Directo, A.C. ne faisait pas partie de ses ONG affiliées. Veuillez trouver ci-dessous une preuve sous forme de capture d'écran, ainsi que la liste des ONG dotées du statut consultatif, qui peut être consultée à l'adresse suivante : <https://undocs.org/E/2019/INF/5> :

7. Enfin, les lettres de soutien de personnes appartenant à la population mazahua incluses dans le dossier datent de 2015. Par conséquent, il est impossible de déterminer la période durant laquelle l'ONG a mené ses activités.

Sur la base de ces faits, il est considéré que l'ONG Desarrollo Gradual Directo, A.C. ne satisfait pas aux critères d'éligibilité énoncés au chapitre III.2 des Directives opérationnelles pour la mise en œuvre de la Convention de 2003.

À la lumière de ce qui précède, le Mexique présente sa position concernant l'ONG Desarrollo Gradual Directo, A.C., soulignant l'importance de mener des processus d'examen exhaustifs de ce type de demandes soumises par des ONG, étant donné qu'elles peuvent générer un précédent pour l'accréditation d'organismes qui, loin de contribuer au renforcement de la Convention, sont susceptibles de compromettre et de dénaturer ses objectifs et son esprit.

La Délégation permanente du Mexique auprès de l'UNESCO saisit cette occasion pour renouveler au Secrétariat de la Convention de 2003 les assurances de sa très haute considération.

Dear Ambassador,

I am writing with reference to the two notes verbales sent by the Permanent Delegation of Mexico to UNESCO on 13 December last (ref. UNE02825 and UNE02826), concerning the accreditation requests submitted respectively by 'Direct Gradual Development, Civil Association' (Mexico; NGO-90481) and the 'Institute for Intangible Cultural Heritage (IPACIM)' (Spain; NGO-90493) to provide advisory services to the Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage.

During its sixteenth session (online, 13 to 18 December 2021), the Intergovernmental Committee considered that information was lacking to determine whether the two above-mentioned organizations satisfy the criteria set out in paragraph 91 of the Operational Directives. The Committee deferred to the General Assembly of States Parties the examination of the accreditation requests of these organizations based on the additional information to be provided prior to its ninth session in July 2022 (Decision [16.COM 15](#), paragraph 5).

The two abovementioned notes verbales contain additional information as required by the General Assembly. In order to ensure that the General Assembly benefit from the full information, the Secretariat intends to first transmit a copy of the two notes verbales to the organizations concerned as well as to the national authorities of Spain (for NGO-90493) for possible comments.

To this end, I would be grateful if you could inform the Secretariat **by 18 March 2022** whether you wish to add any complementary information by writing to [ich-ngo@unesco.org](mailto:ich-ngo@unesco.org). With no reply from your part by that date, the Secretariat will assume that the two notes verbales can be transmitted as received to the organizations concerned and to the national authorities of Spain.

Comments that may be provided by the two organizations concerned will be transmitted back to your Delegation for your information and possible comments. The Secretariat will then make available to the General Assembly the correspondence received from your Delegation and any comments by the two organizations concerned, in their original language.

La Delegación Permanente de México ante la Organización de las Naciones Unidas para la Educación, la Ciencia y la Cultura (UNESCO) presenta sus atentos saludos a la Convención de 2003 para la Salvaguardia del Patrimonio Cultural Inmaterial de la UNESCO, y hace referencia a la solicitud presentada ante la UNESCO por las ONG Desarrollo Gradual Directo, A.C. (ONG-90481) con sede en México, e Instituto del Patrimonio Cultural Inmaterial (IPACIM) (NGO-90493) con sede en España, para ser acreditadas como prestadoras de servicios de asesoramiento al Comité Intergubernamental de la Convención de 2003.

Al respecto, en el caso de a la ONG Desarrollo Gradual Directo, A.C. (ONG-90481), se considera pertinente reiterar la necesidad de llevar a cabo una revisión exhaustiva de los documentos que conforman la solicitud, los cuales de acuerdo con las áreas técnicas sustantivas, ponen en evidencia la falta del trabajo relativo al Patrimonio Cultural Inmaterial de manera específica, que es un requerimiento esencial en este tipo de solicitudes.

En cuanto al Instituto del Patrimonio Cultural Inmaterial (IPACIM) (NGO90493), por la utilidad que pudiera representar, se envía en archivo adjunto la minuta de una reunión celebrada el 25 de marzo de 2021 con la Sra. Isabel Aquino, miembro de la comunidad alfombrista de Huamantla, en la que hace referencia al proceso que se había seguido desde 2015 respecto a la formulación de la candidatura multinacional de “El arte efímero de las alfombras florales”, señalando de manera precisa al Sr. Lluís García Petit, actual Director General de la mencionada ONG.

Por lo anterior, y con base en la obligación de México como Estado Parte de la Convención de 2003 para lograr el cumplimiento de sus objetivos, principios éticos y espíritu de cooperación, las áreas técnicas sustantivas de nuestro país estiman oportuno reiterar enfáticamente la postura respecto a ambas Organizaciones, y con ello colocar el bienestar de las comunidades portadoras como su fin primordial, por lo que reprueban cualquier acción que ponga esto en cuestionamiento. En este sentido, consideran importante mencionar que, el hacer pública esta situación no se debe entender como un acto de bloqueo por parte de los Estados Miembros a las organizaciones no gubernamentales, sino como un acto de responsabilidad y defensa de nuestras comunidades portadoras.

The Permanent Delegation of Mexico to the United Nations Educational, Scientific and Cultural Organization (UNESCO) presents its compliments to the Secretariat of UNESCO's 2003 Convention for the Safeguarding of the Intangible Cultural Heritage, and makes reference to the requests submitted to UNESCO by the NGOs *Desarrollo Gradual Directo, A.C.* (Direct Gradual Development) (NGO-90481) based in Mexico, and *Instituto del Patrimonio Cultural Inmaterial* (Institute for Intangible Cultural Heritage, IPACIM) (NGO-90493) based in Spain, with a view to their accreditation as advisory service providers to the Intergovernmental Committee of the 2003 Convention.

In the case of the NGO *Desarrollo Gradual Directo, A.C.* (ONG-90481), it is deemed appropriate to reiterate the need to carry out an exhaustive review of the supporting documents of the request, which, according to the substantive technical bodies, reveal a lack of work relating in a specific manner to intangible cultural heritage, which is an essential requirement for this type of request.

With regard to the *Instituto del Patrimonio Cultural Inmaterial* (IPACIM) (NGO-90493), the minutes of a meeting held on 25 March 2021, with Ms Isabel Aquino, a member of the *alfombrista* (carpet maker) community of Huamantla, are attached hereto for reference. Ms Aquino refers therein to the process followed since 2015 for the elaboration of a proposal for the multinational nomination of "*El arte efímero de las alfombras florales*" (The ephemeral art of floral carpets) and mentions in particular Mr Lluís García Petit, current Director-General of the aforementioned NGO.

In the light of the above, and based on Mexico's obligation as a State Party to the 2003 Convention to comply with the objectives, ethical principles and spirit of cooperation of the Convention, our substantive technical bodies consider it appropriate to strongly reaffirm their position with respect to the two abovementioned NGOs, thus making the welfare of the tradition-bearer communities their primary aim, and rejecting any action that calls this into question. In this regard, they consider it important to mention that making this situation public should not be understood as an obstruction by the Member States to non-governmental organizations, but as an act of responsibility and defence of our tradition-bearer communities.

The Permanent Delegation of Mexico to UNESCO avails itself of this opportunity to renew to the Secretariat of the 2003 Convention the assurances of its highest consideration.

La Délégation permanente du Mexique auprès de l'Organisation des Nations Unies pour l'éducation, la science et la culture (UNESCO) présente ses compliments au Secrétariat de la Convention pour la sauvegarde du patrimoine culturel immatériel (2003) de l'UNESCO et fait référence à la demande présentée à l'UNESCO par les ONG « Desarrollo Gradual Directo, A.C. » (ONG-90481), basée au Mexique, et « Institut du patrimoine culturel immatériel (IPACIM) » (ONG-90493), basée en Espagne, en vue de leur accréditation en tant que prestataires de services consultatifs auprès du Comité intergouvernemental de la Convention de 2003.

Dans le cas de l'ONG Desarrollo Gradual Directo, A.C. (ONG-90481), il est jugé pertinent de rappeler la nécessité de procéder à un examen exhaustif des documents qui composent la demande, lesquels, selon les organismes techniques de fond, mettent en évidence le manque de travail ayant trait spécifiquement au patrimoine culturel immatériel, ce qui constitue pourtant une exigence essentielle dans ce type de demande.

En ce qui concerne l'Institut du patrimoine culturel immatériel (IPACIM) (ONG-90493), nous avons envoyé en pièce jointe, à toutes fins utiles, le procès-verbal d'une réunion tenue le 25 mars 2021 avec Mme Isabel Aquino, membre de la communauté *alfombrista* de Huamantla, dans lequel elle fait référence au processus qui a été suivi depuis 2015 pour élaborer la candidature multinationale « El arte efímero de las alfombras florales » (L'art éphémère des tapis de fleurs) et mentionne précisément M. Lluís Garcia Petit, actuel Directeur général de ladite ONG.

Compte tenu de ce qui précède, et sur la base de l'obligation du Mexique, en tant qu'État partie à la Convention de 2003, de respecter les objectifs, les principes éthiques et l'esprit de coopération de ladite Convention, les organismes techniques de fond de notre pays considèrent qu'il est opportun de réaffirmer avec insistance leur position à l'égard des deux organisations, et de faire ainsi du bien-être des communautés porteuses de la tradition leur objectif premier, en réprouvant par conséquent toute action susceptible de le remettre en cause. **Numeral 4, Regarding the previous point, and based on the supporting documentation presented, the activities of the NGO can be classified primarily as social assistance, which includes issues such as civil protection, organ transplants and domestic violence that, additionally Due to their lack of connection with the Intangible Cultural Heritage, they are not perceived as part of an integral project, but rather as isolated actions,**

Based on the definition of "Social Assistance", it can be agreed that some of the actions that Direct Gradual Development, Civil Association, carries out are towards strengthening the exclusive powers of the autonomous communities (Charter of Social Assistance of the Union European),

However, considering that Intangible Culture is one of the UNESCO declarations in order to safeguard the history and way of life of the ancestors of a civilization, this allows us to ensure that the actions we have been carrying out since the year 2019, are not far from the protection that the Convention for the Protection of the World, Cultural and Natural Heritage of 1972 itself indicates,

Therefore, we request that all these works be considered in a binding manner with the projects, plans and programs in the field of intangible cultural heritage, actions that are also highly linked to article 22 of the Universal Declaration of Human Rights "(...) All person, as a member of society, has the right to social security (...) through national efforts and international cooperation, taking into account the organization (...) the satisfaction of economic, social and cultural rights, essential to their dignity " ,

Thus, among the Considerations, the deep interdependence that exists between the intangible cultural heritage and the cultural and natural material heritage is manifested, in Direct Gradual Development, Civil Association

We recognize and therefore carry out forceful actions that comply with these guidelines and have been labeled as social assistance actions,

The question is therefore obligatory, for the Permanent Delegation of Mexico to the United Nations, Does social assistance not pay, does it not contribute, is it not binding with the processes of globalization and social transformation?

Considering that, on the one hand, the conditions are created for a renewed dialogue between communities, but on the other hand, they also bring with them, like the phenomena of intolerance, serious risks of deterioration, disappearance and destruction of the intangible cultural heritage, due in particular to the lack of resources to safeguard it,

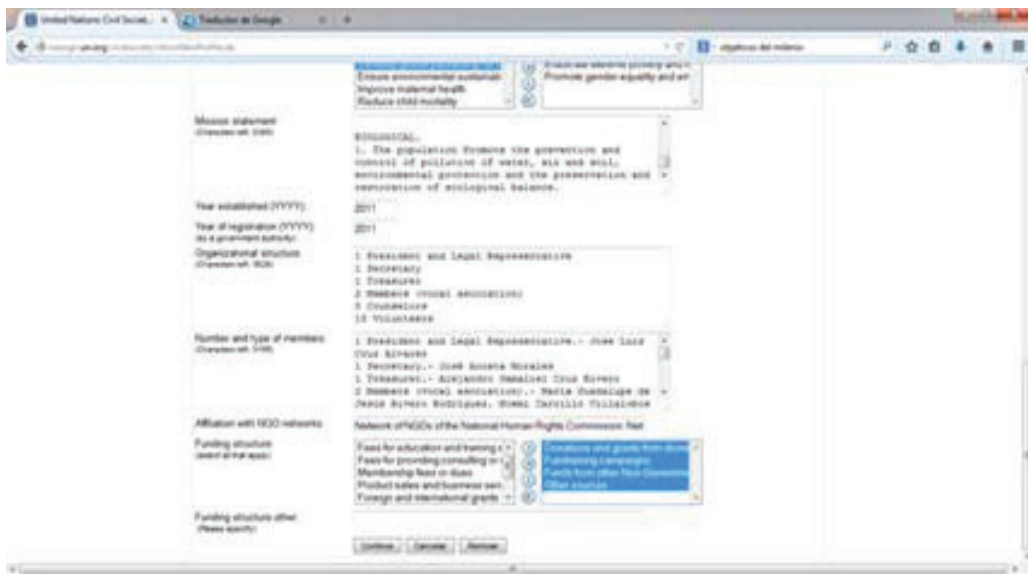

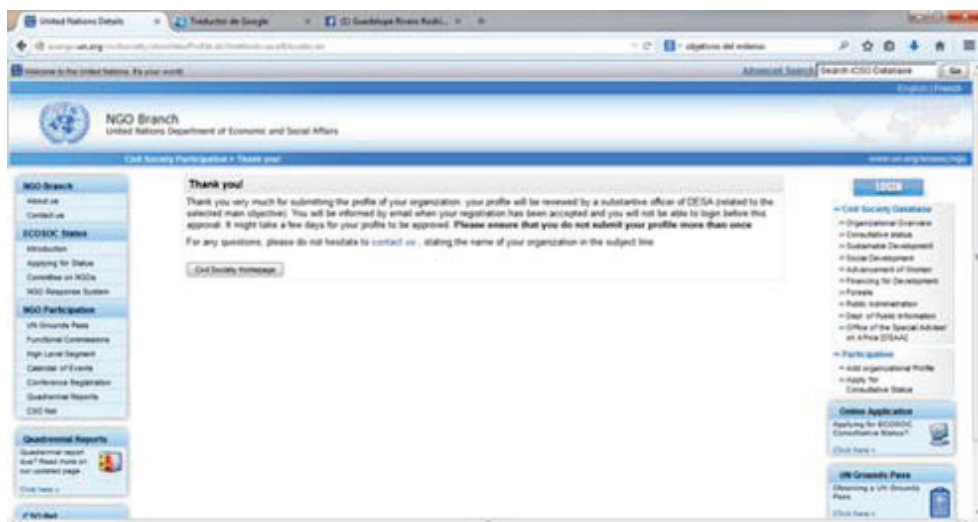

**Figure No. 2 Conclusion of registration with the platform (year 2014)**



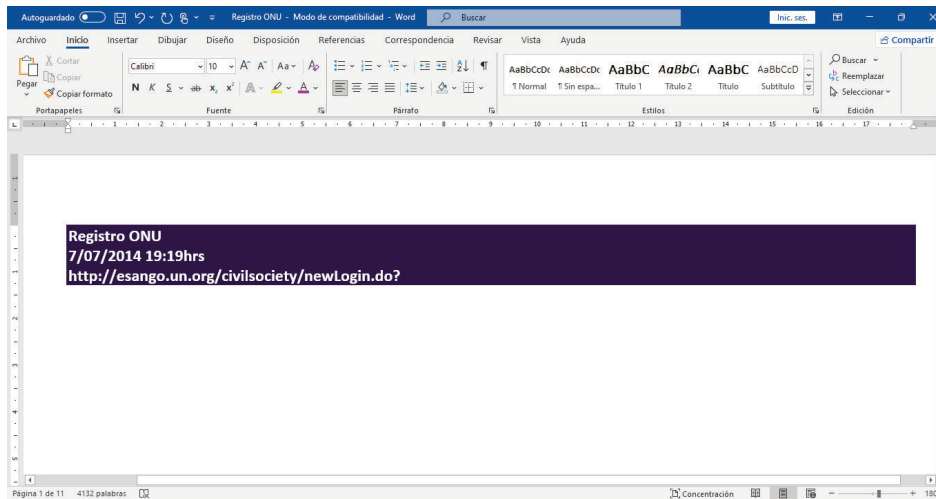
