## 1. Background

The UNESCO Section of Higher Education (ED/E30/HED) is responsible for supporting the Member States in strengthening their higher education systems under the human rights approach, [the 2030 Agenda for Sustainable Development](#), and its pledge to [leave no one behind](#). Within this framework, the Section promotes knowledge development, exchange, and dissemination; provides technical assistance; and develops policy recommendations to contribute to improving higher education capacities at national, regional, and international levels. Among its main upcoming actions, the Section will lead the organization of **the 3<sup>rd</sup> UNESCO World Higher Education Conference (WHEC2022)**, which is expected to take place in **Barcelona, on May 18-20, 2022** (see [Concept Note](#) and [Executive Presentation](#), available in separate files).

The WHEC2022 aims at breaking away from the traditional models of higher education and opening doors to new innovative, creative and visionary conceptions that not only serve the current agendas for sustainable development, but also pave the way for future learning communities that overcome barriers, speak to all and are inclusive of all lifelong learners. The Conference and its preparatory events expect to define and prepare knowledge-based, participatory scenarios to shape a new era of higher education systems (norms, policies, structures, stakeholders) and institutions (universities, specialized entities, think tanks, networks), particularly after the COVID-19 global crisis.

The WHEC2022 will encompass the generation of data, information and knowledge; formulation of updated policy recommendations; identification and dissemination of innovative practices; networking and strengthening of partnerships; broad participation of country stakeholders (highlighting diversity and inclusiveness of higher education stakeholders, within and outside higher education systems, including professors, researchers, administrators, youth, entrepreneurs, policy makers, social leaders, etc.); elaboration and dissemination of a Higher Education Roadmap that is framed by the 2030 Agenda and looks at [the Futures of Education](#).

Under this framework, the WHEC2022 presents the youth strategy (see [Concept Note](#) and [Executive Presentation](#), available in separate files) to ensure youth participation by means of dedicated youth programming that will: (i) empower youth from every background in order to *leave no one behind*; (ii) spark mutual inspiration among youth and the higher education community; (iii) involve youth in a co-building process of redefining higher education. This Conference calls for youth participation worldwide recognizing them as game-changers to contribute to the redefinition of higher education and its future demands.

## 2. Opportunities to engage in the WHEC2022 Youth Strategy

This global invitation is addressed to <sup>1</sup>youth organizations, alliances and young individuals that wish to produce and share knowledge, research, practices, or impactful ideas to enhance higher education institutions and systems, locally and internationally. The invitation is open to diverse entities (within and outside the UN system) willing to establish a partnership with UNESCO under the purpose and main themes of the WHEC2022. Interested intergovernmental organizations, public agencies,

international networks, think tanks, foundations, higher education institutions, students and others, can participate individually or under multi-country or multi-partner alliances. Eligible participants may consider at least six types of activities:

- **Activity A.** Elaborating an open knowledge product (a document reflecting unique evidence or approaches to higher education at national, regional, or global levels).
- **Activity B.** Encouraging policy dialogue by organizing consultation meetings and producing corresponding reports.
- **Activity C.** Elaborating one or more standard policy briefs.
- **Activity D.** Elaborating a short article or blog entrance on a relevant higher education issue.
- **Activity E.** Producing one or more HED-Talks on a relevant higher education issue.
- **Activity F.** Producing one or more podcasts (storytelling, interview, policy dialogue, HED-Talk, consultation) on a relevant higher education issue.

A single youth organization, alliance or individuals may collaborate in all types of activities. Furthermore, one organization may contribute both individually and as a member of an alliance. To enhance synergies with the WHEC2022, it is strongly recommended that these activities are framed under the main themes or subthemes of the Conference and the specific themes of the WHEC2022 youth strategy (see detailed subthemes in **Annex 1** and Youth Strategy topics **Annex 2**).

The contributions referred to in these guidelines will enrich the process of updating knowledge, explore paths on higher education, and prepare its roadmap within the framework of the 2030 Sustainable Development Agenda from youth perspectives, and will be uploaded on the WHEC2022 Clearinghouse and on the WHEC2022 Youth Platform: [www.youthwhec.org](http://www.youthwhec.org). As appropriate, the participating youth organizations, alliances or young individuals may consider UNESCO's references listed in **Annex 3**.

General remark: UNESCO policy is to publish under Open Access (license CC BY SA 3.0 IGO). Rights of the submitted content should be secured by the author(s) and will require the signing of a formal Grant of Rights. This form will be sent to all who have submitted policy briefs, consultation meeting reports, videos or other knowledge products that are selected for publication.

### 3. Activity A. Youth Open Knowledge Products

Participating youth organizations, alliances or young individuals can prepare and disseminate one or more special research or technical reports relating to the WHEC2022 purpose and its main themes or subthemes from youth perspectives. The format of these reports (structure, size, graphic design) is flexible. We strongly recommend that the content of these reports connects with the WHEC2022 main themes or subthemes (**Annex 1** and **Annex 2**); however, organizations may choose “out-of-the box” topics as long as they enrich the availability and use of evidence or approaches and are consistent with the SDGs and the 2030 Agenda for Sustainable Development.

Examples of knowledge products include serial publications, flagship studies, research reports, literature reviews, policy documents, systematization of practices, etc. Knowledge products

considered under this activity are open in the sense that they will become public goods. They seek to strengthen knowledge production and dissemination among stakeholders within and outside of higher education, within public and private sectors, at national, regional, and global levels.

Organizations or alliances may be interested in including the UNESCO logo and a specific reference to the WHEC2022 in their open knowledge product. For this case, a written request from the interested organization(s) and authorization from the UNESCO's Section of Higher Education will be required, and any organizations or alliances external to the United Nations System must include the following text in one of the first pages of the publication:

*This report [publication, document, etc.] is elaborated and disseminated as a contribution to the 3<sup>rd</sup> World Higher Education Conference organized by UNESCO on May 18-20, 2022, with the purpose of enhancing the contribution of higher education institutions and systems world-wide, under the 2030 Agenda for Sustainable Development, its pledge to leave no one behind, and looking at the Futures of Education. The content of this publication does not necessarily express the views of UNESCO or its Member States.*

We kindly ask that youth open knowledge products are submitted via email to the WHEC2022 Secretariat ([whec2022@unesco.org](mailto:whec2022@unesco.org)) as soon as they are ready and no later than **March 15, 2022** (11:59 pm, Paris time). Please insert this title in the email's subject: WHEC2022 Youth Open Knowledge Product.

#### **4. Activity B. Youth Policy Dialogue and Consultation**

Participating youth organizations or alliances are invited to encourage policy dialogue by organizing consultation meetings that will:

- Engage 8 to 12 persons participating on a voluntary basis.
- Take place between August 1, 2021 and February 28, 2022.
- Maximize participant engagement by promoting inclusion and diversity (gender, ethnicity, nationality, knowledge field, different capacities, work experience, etc.)
- Be conducted by one or more moderators.
- Last between 90 and 120 minutes.

The agenda for the consultation meetings may consider the following structure:

1. Introduction (Estimate time: 10%).
2. Presentation of the WHEC2022 purpose and scope (separate PowerPoint available on the [WHEC2022 webpage](#)) (Estimate time: 5%).
3. Questions and exchange (allocate maximum time possible) (Estimate time: 75%).
4. Wrap-up (Estimate time: 10%).

Youth organizations and alliances are kindly requested to prepare a brief report of **1,200 words (Template available in a separate Word file)** that will integrate central ideas captured during the corresponding consultation meeting. The exchanges within consultation meetings may be conducted in any language. If possible, consider sending the corresponding report in one of the three official languages of the Conference: English, French, or Spanish.

We kindly ask that consultation reports are submitted via email to the WHEC2022 Secretariat ([whec2022@unesco.org](mailto:whec2022@unesco.org)) as soon as they are ready and no later than **March 15, 2022** (11:59 pm, Paris time). Please insert this title in the email's subject: WHEC2022 Youth Consultation Report.

### **5. Activity C. Youth Standard Policy Brief**

Youth organizations, alliances or young individuals may prepare standard policy briefs which are expected to synthesize relevant theory and practice on a specific issue relating to one or more of the ten themes of the WHEC2022 (see **Annex 1**).

We kindly ask that final version of policy briefs are submitted via email to the WHEC2022 Secretariat ([whec2022@unesco.org](mailto:whec2022@unesco.org)) as soon as they are ready and no later than **March 15, 2022** (11:59 pm, Paris time).

Please insert one of these titles in the email's subject, as it corresponds with the submission:

### **6. Activity D. Youth Blog Article**

Youth organizations, alliances or young researchers, journalists, among others, are expected to prepare relevant web articles on a specific issue relating to one or more of the ten themes of the WHEC2022 (see **Annex 1 and Annex 2**). Articles will be in a journalistic or informative tone, sharing good practices, evoking a particular initiative or event of your institution/network, and/or providing youth perspectives on a specific issue based on your own story.

The article can also be written from a research perspective, advancing knowledge on a specific field from a new perspective and on an inclusive basis, paving the way for a new gaze and frame, hidden perspectives, and marginalized visions.

We kindly ask that final versions of policy briefs are submitted via email to the WHEC2022 Secretariat ([whec2022@unesco.org](mailto:whec2022@unesco.org)) as soon as they are ready and no later than **March 15, 2022** (11:59 pm, Paris time).

## 7. Activity E. Youth HED-Talk

Youth organizations, alliances or young individuals are invited to produce and submit good-quality and creative videos in HED-Talk format. A HED-Talk is a short video format to draw the audience and the higher education community towards experienced new practices and innovative ideas, in line with the WHEC2022 thematic areas (see **Annex 1 and Annex 2**), the needs of our planet and humanity, and with the Agenda 2030. The video will thus showcase a disruptive, hidden, out-of-the-box, unaddressed idea or perspective on higher education. It will offer a new gaze on how higher education should work, towards what goals, encompassing which stakeholders, among others, to inspire and create impact among audience reactions. Keep in mind that videos should:

- Be short - no longer than 15 minutes
- Focus on a specific question relating to the Conference purpose or main themes.

See below a list of illustrative questions (do not hesitate to think creatively and pose challenging, innovative questions and solutions):

- How may higher education become more inclusive?
  - How to support students to enter, stay and complete higher education?
  - How may higher education respond to changing workforce needs?
  - How may higher education contribute to the sustainability of the planet?
  - How to overcome the digital divide in higher education?
  - Which strategies or practices lead to more outstanding quality in higher education programmes and services?
  - How are contributions in higher education essential for developing sciences, humanities, arts?
  - How to promote international mobility and/or exchanges in higher education?
  - What skills does higher education need to build for current and upcoming generations of youth?
  - How could higher education systems support humans facing challenges posed by the SDGs?
  - How has higher education evolved around you?
- Tell a compelling story or pose a clear argument that promotes awareness among key higher education stakeholders, communicates inspiring ideas, invites higher education institutions to change and innovate, and/or provide evidence of good practices to face higher education challenges.
  - Comply with ethical criteria: property rights in the use of content and images; ensure consent of individuals participating in the video and its sharing on various social media platforms (including Facebook, Instagram, YouTube, etc.); include credits and mention social media accounts as appropriate.
  - Be in English if possible (if audio uses another language, consider translation into English: subtitles, captions) and saved in a MP4 format.
  - Be submitted as a shared file (use OneDrive, Google Chrome, WeTransfer or similar platforms) via email to the WHEC2022 Secretariat ([whec2022@unesco.org](mailto:whec2022@unesco.org)) no later than **March 15, 2022** (11:59 pm, Paris time). Please insert the following title in the email's subject: WHEC2022 Youth HED-Talk Video.
  - Only original pieces will be taken into account: the delivered work should be original and unpublished work, and confirmed as such when submitted to UNESCO.

We invite organizations or alliances to keep in mind these other tips:

- Engage professionals or students specialized in journalism, communications, social media, knowledge management, community engagement, higher education and/or related fields.
- Consider creative, diverse and visual resources: real people, images, sounds, music, pictures, digital animation, etc.

All videos complying with the requirements (be sure to see details in their respective forms) will become available on the [UNESCO WHEC2022 Youth Platform](#) in a collection of resources for the WHEC2022 and future higher education initiatives.

## 8. Activity F. Youth Podcast

Youth organizations, alliances or young individuals are invited to produce and submit good-quality and creative podcasts. The podcasts will showcase a disruptive, hidden, out-of-the-box, **unaddressed idea or perspective on higher education**. It will offer a **new gaze** on how higher education should work, towards what goals, encompassing which stakeholders, among others, to inspire and create impact among audience reactions. Podcasts may present different formats: storytelling, interviews, discussions, HED-Talks, among others.

Keep in mind that podcasts should:

- Be short - no longer than 15 min.
- Focus on a specific question or challenges relating to the Conference purpose or main themes.

See below a list of illustrative questions (do not hesitate to think creatively and pose challenging, innovative questions and solutions):

- How may higher education become more inclusive?
  - How to support students to enter, stay and complete higher education?
  - How may higher education respond to changing workforce needs?
  - How may higher education contribute to the sustainability of the planet?
  - How to overcome the digital divide in higher education?
  - Which strategies or practices lead to more outstanding quality in higher education programmes and services?
  - How are contributions in higher education essential for developing sciences, humanities, arts?
  - How to promote international mobility and/or exchanges in higher education?
  - What skills does higher education need to build for current and upcoming generations of youth?
  - How could higher education systems support humans facing challenges posed by the SDGs?
  - How has higher education evolved around you?
- Tell a compelling story or pose a clear argument that promotes awareness among key higher education stakeholders, communicate inspiring ideas and invite higher education institutions to change and innovate, and/or provide evidence of good practices to face higher education challenges.

- Interview students and/or other higher education stakeholders on the same question to offer different perspectives.
- Comply with ethical criteria: property rights in the use of content and images; ensure consent of individuals participating in the video and its sharing on various social media platforms (including Facebook, Instagram, YouTube, etc.); include credits and mention social media accounts as appropriate.
- Be in English (preferable), French or Spanish and saved in a MP4 format.
- Be submitted as a shared file (use OneDrive, Google Chrome, WeTransfer or similar platforms) via email to the WHEC2022 Secretariat ([whec2022@unesco.org](mailto:whec2022@unesco.org)) no later than **March 15, 2022** (11:59 pm, Paris time). Please insert the following title in the email's subject: WHEC2022 youth podcast.
- Only original pieces will be taken into account: the delivered work should be original and unpublished work and confirmed as such when submitted to UNESCO.

We invite youth organizations and alliances to keep in mind these other tips:

- Engage professionals or students specialized in journalism, communications, social media, knowledge management, community engagement, higher education and/or related fields.
- Consider creative, diverse and visual resources: real people, sounds, music, etc.

#### d. Annex 4. Requirements for Standard Policy Brief

Policy briefs are expected to approach challenges, issues or problems currently faced in the higher education sector. The following requirements apply to policy briefs prepared either individually (one organisation) or under an alliance (more than one organisation).

##### Requirements Policy briefs should:

- Be original, synthetic, sound and updated.
- Be presented in the recommended format (template available in a separate Word file)
- Comply with these criteria:
  - Focus on a relevant, specific, current challenge, issue, or problem in higher education at a national, regional or global level.
  - Be based on rigorous literature review (including theory and practice).
  - Be framed in one of the ten main Conference themes or subthemes (see **Annex 1**).
  - Provide clear recommendations or options for solutions.
- Include a summary that does not exceed 250 words.
- Be written in English, French, or Spanish if possible.
- Use Calibri 11 font, left alignment and single spacing.
- Limit narrative (including footnotes) to a maximum of 4000 words (but exclude bibliographical references and any annexes if the latter are needed).
- As possible, follow the [Style Manual for English texts-intended for publication by UNESCO](#), particularly what refers to quotations (p. 26) and bibliographical references (p. 39-44).
- As relevant, consider the list of UNESCO reports provided in **Annex 2**.
- On the cover page, identify the name of the organisation or members of the alliance submitting the policy brief.
- Be submitted in a Word file via email to the WHEC2022 Secretariat ([whhec2022@unesco.org](mailto:whhec2022@unesco.org)) as soon as they are ready and no later than **March 15, 2022** (11:59 pm, Paris time). Please insert one of these titles in the email's subject, as it corresponds with the submission:

*o WHEC2022 Youth Standard Policy Brief – Organization*

*o WHEC2022 Youth Standard Policy Brief – Alliance*

(Only original pieces will be taken into account: the document should be original and unpublished, and confirmed as such when submitted to UNESCO).

##### Optional features Policy briefs may:

- Below the title, identify its author(s): name, title, and organisation.
- Be supported by consultation and/or other methodologies (interviews, surveys, etc.) to collect data.
- Use tables, figures, infographics, illustrations (properly designed, these may highlight key messages and add value to the document).
