Dear Ms. Coudray,

With reference to the letter of Mr. Guy Berger dated 18 February 2015, I wish to provide you with updated information received from the Hon. Leila M. de Lima, Secretary of Justice of the Republic of the Philippines, on the status of legal investigations being conducted in relation to cases cited by the UNESCO Director-General.

It would be highly appreciated if this information could be included in the Director-General's Report on the issue of the safety of journalists and the danger of impunity.

I. Definition under Administrative Order (AO) No. 35

Pursuant to the Operational Guidelines of Administrative Order (A.O.) No. 35 which serve as its implementing rules and regulations, Extra-Legal Killings (ELK) or Extra-Judicial Killings (EJK) refer to killings wherein:

- a. The victim was:
 - i. A member of, or affiliated with an organization, to include political, environmental, agrarian, labor, or similar causes; or
 - ii. An advocate of above-named causes; or
 - iii. A media practioner; or
 - iv. Person(s) apparently mistaken or identified to be so.
- b. The victim was targeted and killed because of the actual or perceived membership, advocacy, or profession;
- c. The person/s responsible for the killing is a state agent or non-state agent;
- d. The method and circumstances of attack reveal a deliberate intent to kill;

For purposes of the focused mandate of AO No. 35, killings related to common criminals and/or the perpetration of their crimes shall be addressed by other appropriate mechanisms within the justice system. (Art. I, Definition of Terms)

II. Status Updates

Please be informed that to date, out of the fifty-nine (59) cases for the period 2006-2014 cited by the Director-General and attached in a list to Mr. Berger's letter dated 18 February 2015, seventeen (17) are included in the Administrative Order No. 35¹ (AO35) list of a total of fifty-eight (58) verified media killings. The 17 cases include the following journalists:

John Paul Jubelag, Pesident of Mindanao Media Services, provided a copy of the company's certification that the victim was not connected to his company and was an occasional photo provider only for three (3) years without receiving any salary except incentives ranging from PhP 50 to PhP 100 of every prciture accepted for publication. He is neither a writer/columnist nor a regular employee of the tabloid.

The eleven (11) cases were excluded because the motives were not work-related, or victims were not deliberately targeted by reason of the performance of their professions as media practitioners. However, the cases of Aquino Aquino, Ponciano Grande and Eddie Jesus Apostol are subject for further investigation.

The remaining thirty (30) cases listed below involve victims of the Ampatuan Massacre. These cases are being referred to as the Ampatuan Maguindanao Massacre Case (AMMC) which is being handled by a panel of Public Prosecutors.

There are fifty-eight (58) counts of murder charging one hundred ninety-four (194) accused before the Regional Trial Court of Quezon City, Branch 221. At present, there are 194 accused officially charged: 110 are currently detained, all of whom have been arraigned, while eighty-four (84) are still at-large.
