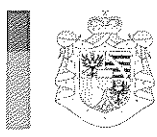

Dear Ms. Rivière,

I have the honour to refer to your letter of 15 December 2009 (Ref. CLT/CIH/MCO/09/657) inviting the Principality of Liechtenstein to submit its periodic report on the implementation of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict and its two Protocols.

Since the submission of Liechtenstein's last National Report on the Protection of Cultural Property in August 2000, no major changes in the relevant legislation have occurred. The explanations contained in that report are therefore still valid and in line with the current state of affairs.

However, Liechtenstein is currently preparing new legislation to implement the Hague Convention and its two Protocols as part of a revision of legislation on the protection of cultural property.

For these reasons of timing, Liechtenstein, rather than largely repeating the information contained in the 2000 National Report, will submit a more substantial report reflecting the prospective legislative changes described above as soon as the revision of legislation on the protection of cultural property will have been put into place.
