Section 3: Steps the Member State has taken to consider the specific risks faced by women journalists in the exercise of their work

The female journalists faced by many challenges and dangers while they seeking for the information:

- 1- Attacks their lives and the body safety by threats, tortures, and sexual attacks.
- 2- Attacks the FoE, as the abduction, arbitrary arrest, enforced disappearance and threats their families or attacks them.
- 3- Reputation abuse such as defamation, intimidation and insults
- 4- The fatwas of terrorists and extremists from armed groups are considered reasons for spreading hostile ideas against civil so ciety organizations, activists and journalists.

The judiciary deals effectively under its laws with issues of impunity, justice and investigations. Iraqi laws have dealt, as shown below, with all crimes against journalists:

- The Iraqi constitution 2005
 - Within the protection of journalists and media professionals, where the state has a duty to protect press and media workers from any danger they are exposed to, such as threats, kidnappings, killings and attacks. Article 14 of the constitution stipulates that (Iraqis are equal in terms of rights before the law without discrimination based on gender, race, nationality, sect, belief, opinion, or economic and social status).
- Article 15 states: "Everyone has the right to life, security and freedom, and these rights may not be deprived or restricted except in accordance with the law."
- Article 19-Third: "Litigation is a safeguarded right guaranteed to all."
- Article 37-first-u referred to (Human freedom and dignity are inviolable) The Iraqi constitution guarantees freedom of expression by all means, and the article stipulates as a member (the state guarantees without prejudice to public order and morals, freedom of expression of o pinion by all means), the second paragraph of the same article referred to (the freedom of the press, printing, advertising, media and publication).
- Panal Code 111 to year 1969
 - The Iraqi Penal Code deals with cases of murder, kidnapping, enforced disappearance, arbitrary detention and torture in general, regardless of the person's status, work or gender.
 - Crimes of murder are criminalized under Article 405 and punishable by imprisonment, while Article 406 is murder associated with aggravating circumstances.
 - Kidnapping the law sets penalties for crimes that target human freedom, and Article 421 referred to the punishment of a kidnapper, who hides or detains a person and deprives him of his freedom with severe penalties.

- As for enforced disappearance, there is no clear and explicit provision in the law to address this situation, but there are acts that fall within its articles (322, 324, 421, 422, 423, 424, 425, and 426).
- With regard to defamation and defamation through the media and social media, Article 433/1 of the law states (whoever insults and insults others shall be punished by imprisonment and a fine or either of them, and if insults and insults are made through the media, it is considered an aggravating circumstance).
- Insulting and cursing through social media and other media, Article 434 referred to (punishable by imprisonment for a period exceeding one year and a fine of 100 dinars or one of them).
- Threatening crime referred to in Article 432 to (Anyone who threatens another by word, deed, sign, in writing, or verbally or through another person in cases other than those set forth in Articles 430 and 431 shall be punished with imprisonment for a period not exceeding one year or a fine).
- If the above crimes are committed through the media, including social networking sites, then they are considered an aggravating circumstance for the penalty prescribed by law.
- Protection of Journalists Law No. 21 of 2011

The law required respect for freedom of the press and expression, to guarantee the rights of journalists and their heirs, and to emphasize their role in supporting democracy in the new Iraq. It came as a complement to the human rights monitor. And it is reinforced under Article II (Strengthening the rights of journalists and providing protection for them in the Republic of Iraq) and also grants the legal guarantee for the journalist to perform whatever his work is freely and easily. And Article 9 stipulates (Punishing anyone who assaults a journalist during the performance of his duties with the penalty prescribed for a nyone who assaults an employee during or because of his job) Article 10 stipulates (It is not permissible to interrogate a journalist or investigate him for a crime attributed to him related to the practice of journalistic work except by a judicial decision).

Anti-Terrorism Law 13 of 2005

He referred to terrorist crimes such as violence, threats and murder. Article II, paragraph 1, stipulates the following acts:

Violence, the threat that terrifies people and endangers their lives, freedom and security, and their money and property to damage, whatever its motives and purposes, is considered the implementation of an organized terrorist project, individually or collectively). Paragraph eight of the above article stipulates (kidnapping or restricting the freedoms of individuals or detaining them or for financial extortion for purposes of a political, sectarian, national, religious or racist nature that threatens the security and unity of the country and supports terrorism) and defines punishments appropriate for these crimes.

• Code of Criminal Procedure No. 23 of 1971

Article 1 refers to every victim of a criminal act has the right to file a criminal lawsuit against the accused, and this applies to every citizen, not just journalists. Article 10 refers to a claim for compensation for any physical or moral harm.

Article 123 questioning the accused within 24 hours of his presence, verifying his identity, informing him of the crime attributed to him, transcribing his statements and granting him the right to plead.

- Draft Law on Freedom of Expression of Opinion and Peaceful Demonstration, Article II of which referred to guaranteeing and regulating the freedom of expression of opinion for all means, and Article 12 of it prevented placing restrictions on freedoms and rights.
 - The bill on the right to access information is still being legislated in the House of Representatives
 - The Information Crimes Law is still under legislation at the Iraqi Council of Representatives, and it guarantees the protection of journalists, and Article 11 of it, Paragraph A (Punishing anyone who threatens or harms by using computers and an information network by committing a felony against himself, his money or the soul or money of others with the intent of intimidating him etc.)
