Across the past 5 years the following employees have gained knowledge and expertise in the implementation of the 2003 convention, by conducting field visits to the communities and practitioners to collect data for the preparation of the nomination files, attending capacity building workshops, filling out the nomination forms, completing all the required documents, and attending the GA of the Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage for the past four years.

Also, SHPS has 350 active members from various fields of cultural heritage, archeology, historians, researchers, and academics which participate in projects and events.

SHPS cooperates with communities and ICH groups through two means:

### 1. Heritage Projects

SHPS has been part of the preparation of ICH nomination file in participation of the local community since 2015 and has worked on seven nomination files. Each file includes field visits with the local communities and the practitioners of the ICH elements. To ensure the inclusion of the practitioners in the nomination process field visits in collaboration with the community were conducted by SHPS :

- Al Ardah Al Najdiya a performance art inscribed in 2015: in Riyadh, Al Ahsa and Qassim
- Almezamar a performance art inscribed in 2016 in Jeddah, Younbu, Madenah, Al Taif.
- AlQatt AlAsiri a traditional craftsmanship in 2017 in Asir
- AlJanadria as best practice to safeguarding intangible cultural heritage prepared in 2017

- Kiswat AlKaaba a social practice and ritual prepared in 2017
- Knowledge and skills related to planting Khawlani coffee beans as a practice related to nature was prepared in 2018
- AlSadu a traditional craftsmanship was prepared in 2018 with Kuwait as a multinational file.
- Albisht Alhasawi a traditional craftsmanship was prepared in 2018 to be inscribed as an element in need of urgent safeguarding.

SHPS events are a reflection the 2003 convention, each event targets a specific ICH domain and aims to raise awareness towards the elements of the domain to present the ICH practitioners to the public, in a modern way to reach the younger generations .
