#### TERMS OF REFERENCE

FOR AN INTERNATIONAL EXPERT TO CARRY OUT 3 DAYS OF PRACTICAL TRAINING FOR KUNDAL (POLYCHROME DECORATIVE WALL PAINTING) TECHNIQUE IN BUKHARA, UZBEKISTAN

#### **Background:**

There are several monuments with Kundal technique in Uzbekistan. These buildings constructed between 1450 and 1650, most of them located in Samarqand and Bukhara. The paintings are in different state of preservation. Some monuments have been recently restored or completely reconstructed, such as Ak-Sarai mausoleum in Samarqand, built around 1470. In some buildings the mural painting has been relatively well preserved, although damaged.

Good example of the usage of Kundal technique is in Abdulaziz-khan madrassah in Bukhara (built around 1650). As this technique is almost disappeared and lack of masters located in Uzbekistan, the UNESCO Tashkent Office want to arrange capacity building activity on Kundal technique in Bukhara in November 2022.

### Requirements for the expertise:

- At least 10 years' experience of applying the Kundal technique in historic monuments;
- Successful experience in several countries in a similar assignment
- Availability for the work immediate
- Knowledge/experience in Uzbekistan/Central Asia is an added value.
- Expected to work jointly with the national expert (s) recruited by UNESCO

## Duration: 3 person/days Main tasks:

- The Contractor shall develop contents and activities for two programmes and agreed the programmes with the UNESCO Tashkent Office: 1 day training for foremen and 2-days of training for young specialists. The programme should cover at least the following subjects: general information about specifics of the Kundal technique, mortar solution, methodic of applying, the tools and etc.
- 2. Conduct 1 day training for foremen and 2-days training for young specialists on site. During the training the expert should explain all the details of the applying the Kundal technique.
- 3. Deliverables:

Submit a finalized training programme for 3-days training by October 31, 2022

Submit a report and recommendations by December 5, 2022
