- 2. To engage UNESCO ICH Experts in Nigeria to identify and carry out research works to inventory Nigeria's rich cultural living heritage;
- 3. To identify particular educational strategies to integrate ICH into research, curriculum and teaching in Nigeria

- 1. We had been involved in capacity building programs at the identification, education and mobilization of indigenous communities;
- 2. Worked twice with the Federal/state governments and UNESCO Regional Office in Nigeria since 2019 to 2021 in the successful organization of community workshops on capacity building at Enugu and Osun states, Nigeria;
- 3. Proposed in 2022 to Government the gains of translation of the UNESCO 2003 Convention English into Nigeria's major languages of Hausa, Igbo,Bakassi,Ikwerre,Ijaw and Yoruba languages to deepen Community education and mobilization;
- 4. We attended several meetings with Government Officials and UNESCO in Nigeria where we also proposed the domestication of the 2003 Convention in the Nigerian National and state Assemblies to establish a superhighway of legal controls and rules that will guide a systematic leveraging on Nigeria's rich ICH Living heritage as a poverty reduction tool and a wealth creation instrument for indigenous communities, women and youths etc

- 1. We initiated policy engagement meetings with the NGO Experts with traditional rulers and heads of communities in Nigeria we described as living heritage treasures;
- 2. We had regular meetings between 2019 and 2022 with some state governors and the Minister of Culture and the Ambassador to UNESCO on best strategies to promote and document for international listing the diverse living heritage of Nigeria;
- 1. At the margins of the 17th.com at Rabat, as the president of the Nigerian Civil Society Platform on Intangible cultural heritage, of which CEPPER is a member, We initiated two meetings with Nigeria's state Delegation to identify challenges facing the implementation

of the Convention in the last decades. The meeting with Ambassador Hajia Gidado was focused on how both state parties and accredited UNESCO NGO Experts could work together to increase the awareness and listing of ICH elements in Nigeria and turn Nigeria ina tourist hub for ICH;How we could domesticate the 2003 and other cultural conventions through the national assembly; Identifying basic ich elements in the 6 geopolitical zones in Nigeria; How to strategically manage financial. logistics and administrative matters; Identifying the core parastatals in ich/culture in Nigeria and their roles-UNESCO delegation, FEDMC,NICO,UNESCO NGO Experts,Fed Min of science etc Expectation of UNESCO NGOs/experts-NISCOSOP as the genuine platform for partnership; Review of past efforts at collaboration and setting new objectives/goals;At the end of the meeting we were required to formally express the resolution reached with the state party and write to the Ambassador(which we have done immediately we came back to Nigeria from the 17th.com);

- 1. New meetings with the state Delegation will harmonise and execute the agenda of the group in Nigeria/2023 budget/working with state coordinators and experts;
- 2. Principal to the agenda is on how to increase cooperation between the state and UNESCO NGOS to implement and provide resources for the execution of the policy goals to safe guard the convention programs in Nigeria
- 3. In the past between 2019 and 2022 we have held successful awareness raising and inventorying workshops for communities in Abuja,Enugu,Benin and Enugu through cooperative facilitation with the states and tour group of UNESCO Experts;
- 4. We are proposing an awareness creation workshop before or at the 18th.com for building the capacity of stakeholders to evaluate and measure the role of gender in the implementation of the Convention. This workshop is proposed to be in collaboration between the Living Heritage Gender working Group and the Gender/Intellectual working group of the NGO Form of which I am the chairman
- **B.7.** Describe your organization's participation in facilitating the engagement of communities, groups and individuals, as well as other stakeholders, for safeguarding intangible cultural heritage.

- 1. In 2018, we drew a community engagement process with the heads of cultural groups in Igbo Wawa land spread across Nigeria, Cameroon and Ghana. Between 2018 and 2022 we could only organize six successful meetings during which we briefed our people on the trending activities of the Conventions. Especially the IGCS and the work of the NGO Forum.
- 2. Challenges of translating the Convention into Igbo Wawa language, financial constraints on increasing the number of indigenes for funding; internal Boko Haram violence that disrupts cultural activities such as masquerades yam festivals, etc were identified at the meetings;
- 3. We were faced with the challenge of setting up a proposal to establish a UNESCO ICH Category 2 Centre at the University of Nigeria which we presented to the Vice chancellor of the first indigenous University which he has approved.But we are yet to get UNESCO approval and how to go about the process. This category 2 Centre when approved by the

Secretariat will cater for the larger needs of the entire country in terms of education, research and building capacity of the state and communities in Nigeria on the Convention

- 1. We had a gender workshop proposal in 2019 which countries such as South Korea and Mexico accepted to sponsor but for the onset of Corvid Nigeria;
- 2. We also proposing an international gender and ICH workshop with UNESCO ICH and other Countries before or at the margins of the 18th .com
- 3. Since 2005,I had been active in organizing the African Group to be well structured to leverage on the gains of collaboration between the UNESCO NGOS and the different state delegations which has led to rotation of key offices between the different regions in the Continent;
- 4. At the 17th.com I facilitated a meeting of the African Group to create an international agenda to leverage the potentials of ICH in the Continent and establish working cooperation with other global stakeholders One of the outcomes of the Rabat meeting was to present a model strategy for embedding ICH into education and achieving cooperation with state parties to the Convention in the coming years
- 5. In Nigeria, Ghana, Cameroon, Niger, and Mali we have been able with the agency of the UNESCO Regional Office in Nigeria to form the Nigerian Civil Society platform on Intangible Heritage and the West African Civil society Platform on Intangible Heritage Matters. CEPPER remains the coordinating core group through which ideas, expertise, facilitation and inventorying work is organized in the Region for other NGOS both accredited and not accredited by UNESCO

It is noteworthy that all our efforts at increasing a more harmonious working relationship with the Nigeria state party both at the NGO level and the NISCOSOP national level of UNESCO ICH experts was to achieve collaboration and working cooperation with the Government of Nigeria so as to Government to create a space for NGO experts to participate at policy formulation and in the preparation of nomination files and the national periodic reports for Nigeria the IGCS. The Arungugu Festival Nomination at Kenya was the only one Government state Delegation allowed our NGO and the national coalition to participate and it bore good results for Nigeria. This is the true spirt of the convention to achieve cooperation of all stakeholders in achieving the goals and objectives of the Convention

We were involved at the community and state levels in the examination of nomination files and serving at the annual evaluation body. However, until quite lately, the federal and state governments have not involved our NGO or the NICISOP in the preparation of nominations to the urgent safeguarding list, representative list, requests for international assistance or proposals for best safeguarding practices. We look forward to UNESCO applying more pressure to the Government in recognizing, at least UNESCO accredited NGOS like CEPPER in Nigeria etc

2. With the meetings we held at the margins of the 17th.com we have hope that arrangements are already underway for mutual cooperative between our NGO and the state

In conclusion, creative and innovative means were documented and subsequently integrated in the operational directions for its successful management. We have added quality assurance mechanisms which we will be happy to added once we are invited to participate in the work of the evaluation body of UNESCO's Living heritage work ...

- 1. We have made direct interventions during the sessions of the IGCS since we were accredited till the last 2023 December 17th.com session in Rabat,Morrocco
- 2. We had been active in the foundational activities of the NGO Forum and the African working Group which had provided documented quantifiable interventions as advisory services;
- 3. We have effectively liaised with our communities, given them feedback and carried out capacity building programs for them within the limited resources we have;
- 4. We have worked with UNESCO in creating more awareness about the convention at the national, regional and global levels;
- 5. We have worked with the state party and the government to successfully organize and facilitate four capacity building and awareness workshops in Nigeria at Abuja,Oshogbo,Benin and Enugu for communities and civil society;
- 6. We have presented our organizational report of programs since accreditation to UNESCO ICH Secretariat, the last one being the 2019 report
