Folkland has been taking up various activities related to advocacy, consultancy and research, supporting the indigenous living heritage, tradition bearers, artistes, local tribal community among others. Folkland has been representing and constantly discussing with various institutional bodies on the gaps identified in existing approaches, policies, schemes and measures to enhance the conservation activities related to intangible cultural heritage.

Capacity building workshops, training to tradition bearers and the artistes, adaptability of primitive art forms, ideas & notions to current trends and expectations, involving future generation, experimenting and promoting sustainability using intangible cultural heritage as a tool are some of Folkland's major focus areas to educate, improve and establish people in the intangible cultural heritage.

Primary aspect is that the working members of the organization largely includes well educated artists and performers from different social sector creating a mutual environment where people can represent and be vocal about the issues, shortcomings they face. They also discuss upon the efforts and help they need to develop forward. This openness within the organization is reflected positively by the communities and groups.

Folkland has a well-planned structure to enrol the artistes and become a member. These artistes are trained and educated prior to the standard of quality expected and constantly communicated about various government/ non-government projects, events & opportunities to participate/perform in the national & international events under our banner.

Seeing the growth, exposure and recognition they receive, other non-artistes, students and young adults show great interest to learn and be part of the process and become members. To train them and filter, various courses, workshops on capacity building and skill development are provided for generating income as well as knowledge sharing.

This constant cycle of respect, equality and growth is the major approach adopted by the organization to involve among various groups and get constant support & cooperation from them.

documents, manuscripts and records are collected to support various existing theories and narrations.

2. Necessary documentation and research are carried out to understand the trajectory and significance of these intangible heritage within the society along with the knowledge shared by tradition bearers. The key challenge is, certain artiste communities are not as vocal as others in sharing knowledge or the process they follow due to various reasons like lineage, belief system, and ritualistic nature. In such cases the goal is to prepare a detailed note on the art form and the artistes practicing the tradition.

Our research and inventory include folklore related to agriculture, nature, fertility, rain, flood, etc., that are recorded and documented.

The members of the organization are not only artistes but also teachers, professors, advocates, bank managers, engineers, doctors, politicians, etc. They take upon various roles in the society creating a platform and position to voice out and discuss the issues faced by the stakeholders & heritage itself. Thus, having their roots in it and possessing immense knowledge in the field with a great sense of responsibility, their suggestions and feedbacks are much valued by the authorities in drawing legal frameworks and guidelines.

Folkland also interfere to resolve issues including lineage within the communities, performers' right, remuneration, etc. Funding artistes in the indigent circumstances, bringing the unsolved issues to government's notice.

Bridging the gap between the generations to create a space for interaction and knowledge sharing. The organization supports for the training for enhancing their capability to earn more.

Folkland educate artistes and students through regular training sessions, workshops, crash course on various art forms, crafts and living heritage, also organize seminars, workshops, exhibitions, competitions and interactive session/activities, etc. The focus group also majorly involve women, transgender, and specially-abled, tribal and other weaker section.

ICH is used as tool for women empowerment, skill development, livelihood, sustainable development.

Yes. Folkland have been extending training to women, young generation, tribes, specially-abled in the traditional performing arts (Koodiyattam, Mudiyettu) and handicrafts (Bell metal crafts. Mural painting, Nettipattam, Handbag making, Palm leaf umbrella making, Terracotta jewellery/decors, etc.) for the past three decades.

To promote the living heritage, Folkland organize various events involving performances, academic seminars, exhibitions, hands-on workshop, etc. Periodic capacity building training sessions for the artistes and staffs, Interviewing and Documenting knowledge on various ICH from the tradition bearers, spiritual rituals & practices belonging to different parts of the state to research, understand and bring forward.
