We developed the remarkable kid course for local authorities and promoters to implement an initiative to identify, revitalize and safeguard elements of their Intangible Cultural Heritage, through elementary school students and the elderly of the community.

The site will be launched on Thursday April 6, 2023.

We worked this method with a group of artisans that builds indigenous musical instruments. 1) We documented their building process; 2) We help them design a certified course for an effective transmission; 3) We help them to register their brand to offer certainty to their potential market; 4) We help them register and certify their unique pieces through the collective certification mark: Living Heritage; 5) We integrated the file for the declaration of geographical indication: Artisan elaboration of instruments for traditional music in the Magical Town of Mineral de Pozos, Guanajuato
