Moreover LtE is an active member of the National Committee for Cultural Heritage and also contributes in several official events (presence of foreign leaders at the Presidency of the Republic etc.)

A special, very successful, scientific meeting on "Dancing activity aspects" was also organized by Lykeion ton Ellinidon (13.12.20 – 6.5.21).

We are particularly interested in folk dances and songs, national costumes, popular poetry, customs, tales etc. We have also very famous folk dances groups performing not only in Greece but also abroad. Our close collaboration with communities relays mostly on our 55 annexes all over Greece.
