During 2019-2022, Memória Imaterial established agreements with Portuguese and international institutions, and formal/informal groups, such as municipalities (15), public libraries, schools and museums, local associations, NGOs and 2 State Departments to work on safeguarding Intangible Cultural Heritage (ICH). We performed this work in all ICH domains in four different

regions of Portugal: North (Melgaço, Monção, Paredes de Coura, Valença), Center (Alenquer, Castanheira de Pera, Figueiró dos Vinhos, Pedrogão Grande, Rio Maior, Torres Vedras, Sertã and Sobral de Monte Agraço) Lisboa e Vale do Tejo (Lisboa), Alentejo (Beja, Évora).

We carried out activities in the scope of information programmes and capacity-building, public information sessions and other participatory methodologies for the safeguarding of ICH. We worked directly with communities, groups and individuals promoting different ICH safeguard measures, such as transmission, education and inventorying ICH (described in the following fields).

Memória Imaterial is also a member of the national ICH working group, coordinated by the UNESCO National Commission and a member of the National Network for the Safeguarding of Intangible Cultural Heritage coordinated by the Portuguese Government – Directorate General for Cultural Heritage (DGPC). In these meetings, we debate ICH safeguard measures and participated in ICH policy discussions.

We participated in the ONG Forum and in the sessions of the Intergovernmental Committee (2019 and 2020). We have also participated in the online meetings of the "Open-ended intergovernmental working group in the framework of the global reflection on the listing mechanisms of the 2003 Convention" (2021).

During the period of the COVID pandemic, the activity of Memória Imaterial suffered some contingency, but we managed to keep executing most of the planned projects, recovering the total activity between 2021 and 2022.

Between 2019 and 2022, the NGO Memória Imaterial carried out work on identification, study and inventory ICH.

Projects usually begin as an answer to requests made by ICH practitioners or by their representatives (local authorities, associations or informal groups). After the first contact, we suggested a methodology based on shared responsibility, where practitioners, civil society representatives, NGOs and people related to ICH are responsible for inventorying in collaboration with heritage professionals and local administrations (with scientific mediation). We work in different levels of communities, groups and individuals' involvement through the inventory process: Informative, Advisory and Mobilizer levels. We present below some inventories made:

As a member of the National Network for the Safeguarding of Intangible Cultural Heritage coordinated by the Portuguese Government – Directorate General for Cultural Heritage (the legal administrative institution of the national ICH policies program) we participated in the work to define the National Strategy for the ICH (2021-2025) and its implementation.

"The contribution of the National Strategy of the ICH to the fulfilment of the proposed goal will be based on the implementation of the measures embodied in the following strategic axes: 1 - Identification and Safeguarding; 2 - Recognition and Promotion; 3 - Communication, Training, Education and Citizenship; and 4 - Creation of Networks and Partnerships." (...)

"The following measures in the National Strategy for the ICH are highlighted: hold information sessions for Local Authorities and Technicians with a view to raising awareness of safeguarding the ICH through knowledge and appreciation of the contribution of intangible cultural expressions to the promotion of quality of life and social cohesion of communities; promote information and awareness sessions aimed at communities, groups and individuals

holding ICH, aiming at the application of participatory methodologies" in the processes of organization and submission of applications for inscription in ICH inventories. "Raise awareness in the educational community for the preservation and enhancement of the ICH; develop and support mediation and non-formal education initiatives in Museums and other spaces of culture and education, aiming at the enhancement and safeguarding of the ICH in Portugal, with respect for cultural diversity, sustainability and human rights."

Considering the period 2019-2022, MI promoted the role of ICH and its safeguarding in different ways. We summarize our work underlining the production, publication and dissemination of online platforms and pedagogic ICH resources. We have also created an exhibition on oral tradition, which is on national tour to increase the number of people interested in these cultural expressions while cooperating with different communities:

During the exhibition, we promoted narrative sessions, where new storytellers worked with a large audience – schools, senior centers, associations and other local institutions and groups. This exhibition is the result of a collaboration between Memória Imaterial, IELT-NOVA FCSH and Museu Nacional de Arqueologia to promote and transfer knowledge between intangible cultural heritage, scientific research and performing arts. It is expected that this initiative will promote interest in oral tradition and ICH archives on traditional literature.

Memória Imaterial develops activities to raise awareness about different dimensions of ICH safeguarding. To give two examples, we will refer to an action promoted to raise awareness of the cultural and social function of ICH, and we will describe an action to raise awareness of the participation of practitioners in the ICH inventories.

About the ICH cultural and social function, we underline the project "Uma roda, entre histórias" ("A circle, between stories"). This project works on the importance of oral tradition. Starting with recording sessions of traditional stories in the Alto Minho (2022), a new generation of practitioners restores an ancestral space of sharing affections, knowledge and hopes of a heritage that, rooted in the landscape, speaks of cultural identity, cultural diversity, social and human bonds. Until now (2022-2023), this work has been presented in 40 communities, reaching an audience of one thousand people.

Considering the importance of the participation of communities, groups and individuals in the safeguarding process, we carried out information meetings to engage different ICH actors in the inventory process. For instance, at the beginning of the ICH inventory process, we promote informal meetings to understand the meaning that communities' representatives give to the concept of Intangible Cultural Heritage. Meetings about "What is ICH?". With that information, we work together to decode the 2003 Convention and define the working steps of the inventory.

Considering our work between 2019-2022, we can describe, with some examples, different participatory methodologies and different levels of engagement of communities, groups and individuals in ICH safeguarding:

We achieved an advanced level of engagement in the project "Monsalude inventory ICH
and memories". In this initiative, the inventory process started with the request of 3
different communities (Pedrogão Grande, Castanheira de Pera e Figueiró dos Vinhos).
With our partnership (capacity-building actions), these communities self-mobilized and
managed an inventory process, created their own database, collecting their own ICH and
promoting it.

We achieved a medium/mobiliser level of engagement, for instance, in the inventory
process made with the communities of Rio Maior. In this case, we worked in a shared
responsibility relationship, in a commitment through which the community, groups and
individuals of practitioners and other stakeholders were partners and co-authors of the
inventory process - planning and evaluation. However, we (Memória Imaterial) built the
database structure, recorded the testimonies on video and published the work.

We achieved an informative/mobiliser level of engagement in several works of ICH raising awareness and promotion - information sessions, interviews, working meetings, surveys and group dynamics. In these cases, ICH communities, groups and individuals were active as informants or consultants. For instance, in 2020, our project DIGITAL ICH Observatory conducted the international survey "Inventories & Intangible Cultural Heritage (ICH)" to collect information and analyse the practices and opinions of users of ICH Inventories.

MI participated in the first and second meetings of the Iberian NGOs accredited by UNESCO to provide advisory services to the Intergovernmental Committee in the framework of the 2003 UNESCO Convention for the safeguarding of ICH (1st Meeting, Barcelona-Spain, May 2019; 2nd Meeting, Costa da Caparica Portugal, November 2019).

MI is a member of the «Group for the Safeguarding and Promotion of the Mediterranean Diet» (created by the Portuguese Ministry of Agriculture and Sea). In this group we participate in the implementation of safeguard measures (considering the multinational nomination with Croatia, Cyprus, Greece, Italy, Morocco and Spain and inscribed in the Representative List in 2013). This group integrates the Portuguese representative community (Tavira), the National Commission for UNESCO, the Directorate for Cultural Heritage; IELT, Order of Nutritionists, Movement

Women in Red and the Portuguese Foundation of Cardiology.

Our organization's contribution to the drafting of the State's Periodic Report was a written report requested by the Directorate General for Cultural Heritage about our activities in 2021.

From that activities, the Portuguese State highlighted the inventory work of our NGO in "Memoriamedia", an online inventory that plays an important role in raising awareness for the safeguarding of ICH and disseminates to the general public the results of its documentation projects of ICH in Portuguese territory. Besides its participation in international seminars and workshops, either in Portugal and in other countries. It is also highlighted the NGO-based initiatives provide training in ICH safeguarding and management, on an inclusive basis.

As we will describe in field E.3, during the period 2019-2022, our organization developed a vast work of evaluating and analysing documents proposals or applications to UNESCO's Lists and proposals of Good Safeguarding Practices, at the national level (7 processes in total). That was our involvement in these processes. In that period, we didn't participate effectively in the preparation of nominations.

However, we collaborated (with and on request of the Alenquer municipality) with research contents and documentation for the preparation of the file "Pintar e Cantar dos reis Alenquer" to be submitted to the ICH National Inventory.

It should be noted that, in the past, Memória Imaterial participated in the preparation of two nomination files for the Representative List - "Cante Alentejano, polyphonic singing from Alentejo, southern Portugal", and the multi-national file – "Falconry, a living human heritage".

Since 2014, Memória Imaterial is a member of the national ICH working group, coordinated by the UNESCO National Commission. In these group are also present two other Portuguese accredited ONGs (Fundação INATEL and CRIA), the UNESCO Chair in ICH of the University of Évora and the Directorate General for Cultural Heritage - the State institution responsible for developing the ICH national policy. In this group, above all, and considering the 2003 UNESCO Convention and its Operational Directives, we participate in the analysis of requests for inscription on the Urgent Safeguarding List; on the Representative List and proposals of Good Safeguarding Practices.

In 2020 and 2021, we Cooperated with The UNESCO Chair in ICH of the University of Évora participating in the International Conference "The Intangibles of Heritage: concept, recording, safeguarding" (Organized by Erasmus Mundus Master TPTI & HERITAS – UNESCO Chair) with the communication "The MEMORIAMEDIA project – recording and safeguarding ICH". (September 2020) and participation in the seminar "Museums and PCI in Alentejo and the lusophone world", organized by the UNESCO/EU Chair and the UNESCO Centre of Beja (July 2021).

Memória Imaterial has contributed to the ICH Ngo Forum Statement at Committee meeting or the General Assembly and we always respond promptly to the request for fill ICH surveys promoted by the Secretariat, but, as we mentioned in point D.2, we never provide services directly to the Committee.

We think that in the future we might provide these services because we have ICH experts working with us and our experience and knowledge could be mobilized for that purpose. We can demonstrate skills to evaluate nomination files, but we would be even more interested in giving our advice on other matters, namely: evaluation of the impacts of the safeguard on the inscribed elements; on the implementation of participatory methodologies in safeguarding processes; to advise on facilitators/mediators training and the necessary skills in participatory methodologies (relational, theoretical and technical skills); on how to integrate ICH into school programs (or, more importantly, how schools and their students can have direct contact and be involve with living practices, in their own context (in their place, time and rhythm); how to enhance the NGOs experience, promote the ethical principles, shares good practices or strengthen the collaboration and dialogue to the Committee or to the Electoral group.

Memória Imaterial performs its work in all ICH domains - oral expressions; know-how; festivities and rituals; performance practices, and knowledge and practices related to nature and the universe. Accessing the MemoriaMedia inventory it is possible to verify that cultural expressions are organized in these domains. However, we experience that many domains of the intangible culture are interconnected. For instance, oral expressions, such as traditional stories, are often related to social practices, knowledge of nature or even the know-how.

As an example of this connection, we describe one activity held in 2022 with three different communities – Torres Vedras, Alenquer, and Sobral de Monte Agraço. We are talking about "Farinha do mesmo saco I e II" ("Flour from the same bag I and II"). In the West of Portugal, the mills punctuate the landscape. Being fundamental in community life for centuries, they left a stun of memories and stories that still populate our imagination today. Currently, there is a movement of recovery and reuse of mills. Considering these facts, Memória Imaterial brought together storytellers, artists, millers, mill owners and researchers in sessions, to schools and to all publics, where dimensions of this cultural expression were worked – know-how; knowledge of nature (for instance, the wind movements); traditional stories and other. These activities were framed in a broader initiative called "A Festa do LU.GAR" ("The Festival of the PLACE"), which had an audience of nearly three thousand people.

Memória Imaterial has experience in evaluating and analyzing proposals, applications and reports. Several staff members participate regularly in evaluation committees. We are member of the National ICH Working Group, committee that evaluates all Portuguese nominations to the UNESCO lists.

The national ICH working group is coordinated by UNESCO National Commission. With the participation of other two Portuguese accredited NGOs (Fundação INATEL and CRIA); the UNESCO Chair in ICH of the University of Évora and the Directorate General for Cultural Heritage, this group analyses requests for inscription on the Urgent Safeguarding List, the Representative List and proposals of Good Safeguarding Practices.
