200 models from this number were also handed over to the participants to the Mediterranean <u>Fira</u> <u>Mediterrània de Manresa</u> of the years 2020 and 2021. It is the most important traditional music

There have also been published articles on numerous intangible cultural heritage expressions: blowing bells, *muixerangues*, popular music and traditional games.

The Department of Culture of Catalonia is elaborating the Intangible Cultural Heritage and the Cultural Associations Law. We have presented amendments, agreed by the 30 federations that make up our entity, so that the new regulations can gather the spirit of the Convention.

In parallel, we have reached the agreement of the Department of Culture to include a technician who understands intangible cultural heritage in the Consultive Council of Catalan Cultural Heritage, since, until now, it is nonexistent.

It is common journalists affirming in an incorrect way that the UNESCO has declared a cultural expression as intangible cultural heritage of the humanity. From ENS we work a lot to revert this vision, to make people understand that, if the Intergovernmental Committee has the power to inscribe a candidacy to the Representative List, the power to define an element as a PCI belongs to the practicing community. In all events that promote Intangible Cultural Heritage which are organized by ENS, commit this idea; it is underlined, in other words, that the process and safeguard of the intangible cultural heritage requires the implication of civil society and it cannot be delegated exclusively to technicians and experts.

ENS edits the cultural magazine called <u>Tornaveu</u>, through which news on intangible cultural heritage are published: lectures, symposiums, conferences, making inventories, publications, legislative news, preparation and registration to the UNESCO candidacies, etc.

Through *Tornaveu*, the experience of the ENS of Cultural Associations to the Intergovernmental Committee that safeguards the Intangible Cultural Heritage is also published every year.

ENS is part of the observatory of the <u>Intangible Cultural Heritage of Terres de l'Ebre</u>. This organization has the highest political organizations in Catalonia (Generalitat and Provincial Deputations, Comarcal Councils), and the Rovira i Virgili University of Tarragona and the Museum of the Terres de l'Ebre.

Since the certification of ENS as an NGO recognized by the UNESCO (2014), we have participated in all the meetings of ICH NGO Forum. We contributed to consolidate the ICH NGO Forum with the organization in Catalonia of the <a href="Ist International Conference of NGOs Accredited by the Convention for the Safeguarding on Intangible Cultural Heritatge">International Conference of NGOs Accredited by the Convention for the Safeguarding on Intangible Cultural Heritatge</a> (2015). From then on, it has participated regularly in the working meetings of the ICH NGO FORUM.

ENS has also participated in the two meetings of Iberian NGOs Recognized by the Convention for the safeguard of the Intangible Cultural Heritage, celebrated in <u>Barcelona</u> (30<sup>th</sup>-31<sup>st</sup> May, 2019) and <u>Lisbon</u> (21<sup>st</sup>- 22<sup>nd</sup> November, 2019).

Since May, 2018, we have a collaboration agreement with the Mexican NGO called "Interactividad Cultural y Desarrollo."

The <u>National Council for Culture and Arts (CoNCA)</u>, which depends on the Department of Culture of the government of Catalonia, publishes the *Annual Report on the Condition of Culture and Arts*. The diagnosis of the years 2021 and 2022 on intangible cultural heritage has been drafted by ENS.

As it has been already said, ENS had a main role in the consolidation of ICH NGO FORUM. It was considered fundamental to have an international organism that represents all the entities that work to safeguard the intangible cultural heritage.

We consider that the main contribution that ENS can make for the Committee is to explain how the inventories of the intangible cultural heritage are done in Catalonia. To our understanding, it is a good practice of implication of collaboration between administration and society. According to their objectives, these inventories can be classified in the following way:

**-Thematics.** They make reference to a cultural expression. Inventories that are lead from the cultural associations, particularly for two entities which are associated to ENS: <u>l'Esbart Català de Dansaires</u> i l'<u>Agrupació del Bestiari Festiu i Popular de Catalunya</u>

Objective: To safeguard a cultural expression and to promote their modernization. Cases: 1) Inventory of Alive Dances of Catalonia; 2) Inventory of the Festive Beasts

**-Territorials.** To make inventories of all the cultural expressions of a region. The Centres of Study have a main role.

<u>Objective</u>: Through the promotion and safeguard of the intangible cultural heritage, to achieve economic, educative and social benefits of a territory.

<u>Cases:</u> Intangible cultural heritage of the Terres de l'Ebre inventory; 2) Inventory of the Penedès; 3) Inventory of the Vallès; 4) Inventory of the Priorat; 5) Inventory of the Gavarres; 6) Inventory of Mallorca.

In Catalonia, the social applicability of the inventories of the intangible cultural heritage is very present. We consider that it is important to have an impact on this line of work to achieve two objectives: 1) To reinforce the collaboration between the Intergovernmental Committee and the practising communities, through the NGOs; and 2) To promote the implication of the so called practising communities in the making of inventories, understood as a indispensable tool to safeguard their own intangible cultural heritage.

He was the coordinator of "The Methodology for the Intangible Cultural Heritage in the Biosphere Reserves: Montseny Experience", registered in the list of Good Practices of the Safeguard of the Intangible Cultural Heritage (2013). Previously, he worked in the Centre of UNESCO in Catalonia between 1996 and 2012.

Nowadays, Garcia works in the Inventory of Intangible Cultural Heritage of Menorca and the candidacy of the *sardana* in the Representative List of Intangible Cultural Heritage. Therefore, he has wide experience and competencies.
