In the Republic of Korea, there are four accredited NGOs (IMACO, KCHF, WoMAU, CICS), working in different fields with the common goal of safeguarding intangible cultural heritage.

Every twice a year, four NGOs conduct a capacity-building workshop to communicate and collaborate in order to strengthen the network. Each NGOs report its activities throughout the year and have an opportunity to share its initiatives and knowledge. Four NGOs discuss enhancing the roles of NGOs in the Intangible Cultural Heritage sector and cooperating with

each other to build up institutional and human capacities for safeguarding intangible cultural heritage.

In addition, IMACO is participating ICHNGO forum through the intergovernmental committees as well as online platform. IMACO shares the current situations and experiences related to intangible cultural heritage information in each country, such as subjects handling intangible cultural heritage information, relevant policies or institutions, infrastructure, scope, and volume of information held.

IMACO offers variety of educational programs for the transmission of mask dance among young people.

As a side event of the international conference, IMACO conducted special educational programs (mask dance class, mask making class etc.) for elementary school students in cooperation with the Mask Dance drama safeguarding association, and local government.

In addition, IMACO publishes educational materials to ensure the systematic transmission of mask dance. The material consists of dances, songs, and dialogue essential to the performance of each region's mask dance dramas, and also on mask-making skills and relevant history and culture. These materials disseminate from elementary school to high school.

B.3. Describe your organization's participation in the **inventorying and research** of intangible cultural heritage. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

IMACO has developed a long-term plan to establish an International Mask Culture Archive, a hybrid platform combining an online archive with an offline museum that will provide interested individuals, groups, and communities with easy access to relevant information.

The Archive project systematically collect and preserve disappearing mask culture materials to be used for art creation, research, and education to become a place of knowledge that encourages the use and reproduction of mask culture content to enhance the value of intangible culture.

As both an international and domestic organization, IMACO will not limit the scope of its activities to simply mask culture, but will address intangible heritage in general through its exchange programs, organization of events, and other safeguarding efforts.

B.4. Describe your organization's participation in developing **policies, as well as legal and administrative measures**, for safeguarding intangible cultural heritage. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

IMACO consistently makes a platform between the central government, local governments, and communities to share various ideas actively on how to preserve and protect Korean mask dance drama, form and reinforce mutual networks, and develop plans through best practice analysis.

IMACO is organizing an annual policy forum that shows a valuable opportunity to safeguard intangible cultural heritage and contribute to the promotion of human creativity through close exchanges between cultural artists and organizations related to mask dance at home and abroad. During the policy forum, policymakers and stakeholders also gather in one place to promote understanding and cooperation, and to form a discourse for the sustainable development and globalization of mask dance drama.

B.5. Describe your organization's participation in promoting the **role of intangible cultural heritage and its safeguarding in society**. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

IMACO is conducting school visit program, which cooperate with local government to educate and promoting the role of intangible cultural heritage and its safeguarding in society. IMACO participate as a special guest lecture, and give explain about the importance of intangible cultural heritage, and future direction of safeguarding intangible cultural heritage.

In addition, IMACO joins many ICH festivals and events by operating a promotional booth. IMACO promotes safeguarding activities to the public, and showcased ICH and mask culture videos, books, brochures that were produced.

IMACO is promoting awareness of the importance of ICH in the communities where pertinent events are held such as theaters, schools, and cultural facilities.

IMACO has been supporting public events and festivals relevant to mask and mask dance in different places and occasions such as performances, exhibitions, and workshops. Especially, IMACO constantly supports Andong Mask Dance Festival, which is a sequence of events that is held yearly. Numerous visitors visit every year and enjoy shows of Korean mask dances.

During 10 days of event, IMACO produces various media and publications such as web-magazine, children's books, and many other types of content to raise public awareness of Mask dance. In addition, the international mask exhibition aims to raise local awareness and introduce foreign tourists to the art of International masks.

B.7. Describe your organization's participation in **facilitating the engagement of communities, groups and individuals, as well as other stakeholders, for safeguarding intangible cultural heritage**.

IMACO holds annual mask symposium to deepen research in the field of mask culture from broader perspectives, including issues such as the origin, transmission, myths, rituals, communities, performers, craft, preservation of mask, and its culture. The symposium explores the roles of ICH in multicultural, cosmopolitan societies, especially in terms of promoting community identity and fostering intercultural understanding among diverse communities.

The speakers and audience of symposium include international ICH experts, NGOs, ICH associations and practitioners, heritage groups and enthusiasts, academics, researchers, and students.

As a result, the mask symposium promotes the sharing of international best practices in safeguarding and promoting Mask cultures and facilitates networking and relationship building among ICH experts from different parts of the world.

Since its establishment in 2006, IMACO holds an international conference and symposium every two years for active exchanges among international members and strengthening the network and research on the mask culture of the co-host country.

IMACO hosted the first international conferences in Andong (Republic of Korea), followed by others in Bangkok (Thailand), in Singaraja (Indonesia), in Thimphu (Bhutan), in Shanghai (China), in Vientiane(Laos), in Bacolod (Philippines).

In December 15th 2022, the 8th International Conference was held in Andong, Republic of Korea. This conference is more meaningful than ever as it's held immediately after 'Talchum-Korean mask dance drama' was inscribed on the UNESCO Representative List of the Intangible Cultural Heritage of Humanity at the 17th session of the Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage held in Rabat, Kingdom of Morocco

The conference consists of various programs including mask exhibitions, academic symposiums, policy forum, and cultural performances. The conference promotes the importance of mask cultures, and expand Korea mask dance drama whose value were recognized as a universal traditional culture by the international community and to shed new highlight on the historical value of mask dance internationally.

In 2024, our possible next venue is Solo City (Indonesia) ; IMACO is already working on our documents and make an engagement in cooperation with city governments and mask museums in Solo City.

Along with the Cultural Heritage Administration(CHA) and representatives of the communities, IMACO has actively cooperated in the preparation of nomination for inscription on the representative Lists.

The nomination dossier was drawn up and modified based on consultation with the communities and stakeholders. Safeguarding associations, the General Federation of Mask Dance Safeguarding Associations and IMACO have all closely cooperated throughout the entire nomination process from the initial agreement on the need for inscription to the preparation of the nomination file and drawing up of future safeguarding measures.

As a result, "Talchum, mask dance drama in the Republic of Korea" has inscribed as Representative list of the intangible Cultural Heritage of Humanity on November 30, 2022 at the 17th Session of the Intergovernmental Committee in Rabat, the Kingdom of Morocco.

IMACO has been organizing many international conferences and symposiums in order to share experiences for the safeguarding of Intangible Cultural Heritage, especially in Mask Culture.

In December 2022, 2003 Convention's Global Network of facilitators actively participated in IMACO international conference 2022 (name sponsored by Cultural Heritage Administration, and Korean National Commission for UNESCO) by presenting presentations and shared their opinions contributing to raising awareness of the importance of the Intangible Cultural Heritage and ICH NGOs' roles. IMACO also consistently cooperated with the category 2 center (ICHCAP), and 3 other Accredited NGOs (Korea Cultural Heritage Foundation, World Martial Arts Union, The Center for Intangible Culture Studies) in Korea.

In particular, IMACO supports many mask festivals in the world to vitalize the performances and festivals for mask cultures. IMACO helps festival organizations by inviting mask practitioners from our member states.
