Como, Italy - 22-24 April 2024**

BILT Bridging Events are organized consecutively in each of the three focus regions of the ‘Bridging Innovation and Learning in TVET’ (BILT) project – Africa, Asia-Pacific, and Europe – and hosted by a UNEVOC Centre that is an active networking node for TVET stakeholders in the region and beyond. BILT Bridging Events provide a platform for international policy learning, knowledge exchange, innovation transfer and networking among TVET policymakers, practitioners and researchers.

The 2024-2025 cycle of Bridging Events kicks off with the conference in Europe, hosted by **La Cometa Società Cooperativa Sociale (Cometa)**, with a thematic focus on inclusive excellence in TVET.

BACKGROUND

Excellence in technical and vocational education and training (TVET) is multifaceted and defined in diverse ways. Although there is no single universally accepted definition of vocational excellence, most conceptual frameworks incorporate two important components: the delivery of **high-quality TVET**, and the impartation of skills and competencies that **enhance the employability of all people** striving to find decent work.

In this regard, excellence and inclusion in TVET are mutually reinforcing. Inclusive excellence in TVET is a commitment to meet the needs of all learners, regardless of their social and educational background, gender, ethnicity, disability, or migration status.

Based on this understanding, the BILT Bridging Event *Towards inclusive excellence in TVET* seeks to **explore various approaches to inclusive excellence** in TVET systems **across Europe, Africa, and Asia-Pacific**. Taking European perspectives as a starting point, the event will promote **interregional policy dialogue and cooperation** to support inclusive TVET systems that provide high-quality TVET delivery.

The BILT Bridging Event aims to contribute to the implementation of the **Education 2030 Agenda** and its 17 **Sustainable Development Goals**, in particular SDG 4, “ensure inclusive and equitable quality education and promote lifelong learning opportunities for all”. The [UNESCO Strategy for TVET 2022-2029](#) is fully aligned with SDG 4 and underlines UNESCO’s goal to unlock the potential of youth and adults by transforming TVET for successful and just transitions.

With its thematic focus on inclusive excellence, the event will also support the implementation of the [Strategic framework for European cooperation in education and training towards the European education area and beyond \(ET 2030\)](#), particularly its first priority, “Improving quality, equity, inclusion and success for all in education and training”; the African Union’s Year of Education on the theme “[Educate an Africa fit for the 21st Century: Building resilient education systems for increased access to inclusive, lifelong, quality and relevant learning in Africa](#)”; and the [ASEAN Declaration on Human Resources Development for the Changing Worlds of Work](#).

GOALS

The BILT Bridging Event *Towards inclusive excellence in TVET* enhances the visibility of BILT in Europe and beyond. It aims to:

- **Promote policy learning** between TVET stakeholders in Africa, Asia-Pacific and Europe. Taking lessons from Europe as a starting point, the focus is on
 - Discussing policy **approaches to inclusive excellence**;
 - Re-orienting current TVET policy towards inclusion and excellence and promoting TVET as an attractive career path.
- **Support peer learning** among BILT community members **on concrete innovative approaches to**
 - **Foster international collaboration** between TVET institutions striving for inclusive excellence in TVET delivery and TVET research;
 - **Implement inclusive TVET**, integrating migrants and disadvantaged youth, and targeting NEETs (persons not in employment, education or training).
- **Invite the TVET community in Europe and beyond to collaborate with BILT**
 - In the context of the sectoral **BILT Expert Groups** on new qualifications and competencies in building and construction (new in 2024–2025) and in hospitality and tourism (continued from 2023);
 - As **contributors** of transferable Innovation and Learning Practices (ILPs), or partners for future BILT events.

DELIVERABLE

A **working paper on definitions of “inclusive excellence”** reflecting TVET approaches in the three BILT regions – Africa, Asia-Pacific, and Europe – will synthesize the results of the discussions held at the conference.

TARGET GROUP

In-person participants and speakers (by invitation):

- TVET decision makers and TVET research agencies advising policymakers;
- TVET experts from UNEVOC Centres and from international organizations;
- Selected members of the BILT Expert Groups;
- Subject matter experts on the focus sectors or focus themes; and
- Private sector representatives, associations, and unions.

Online participants:

- TVET experts and stakeholders from ministries, national bodies, TVET providers and research institutes;
- Private sector representatives; and
- TVET teachers and trainers.

The BILT Bridging Event Europe in Como, Italy, will bring together approximately 60 representatives of primarily European, as well as African and Asian UNEVOC Centres and members of the BILT community.

During the three days, selected plenary sessions will be **streamed online**. Online participation is open to a **global audience**.

FORMAT OF THE EVENT

Duration: 22-24 April 2024 with the following objectives:

- **Day 1: Promoting inclusive excellence**
 - Keynote and discussions with policymakers, industry partners, and TVET role models from Africa, Asia-Pacific and Europe on the pursuit of inclusive excellence.

 - On-site study visits to interact with practitioners in the TVET system in Italy (trainers and trainees) and to have a first-hand impression of on-the-job training.

 - Networking sessions are organized to strengthen cooperation and thematic exchange among UNEVOC Centres and TVET institutions present at the event.

 - Hybrid Learning Lab with a focus on inclusive TVET approaches in the hospitality and tourism sector.

Priscilla Gatonye supports the development and implementation of the UNEVOC Network strategy, with a particular focus on the thematic area of inclusion and youth, including the International Centre’s ongoing work on entrepreneurial skills development, and gender equality in TVET. She also acts as Regional Focal Point for Africa and in this capacity develops regional strategies to involve members of the UNEVOC Network in Africa in UNESCO-UNEVOC’s activities.

Previously, Ms Gatonye worked for 10+ years in various capacities within the TVET sector as well as in youth empowerment and employability advisory. Priscilla holds a B.A. in Economics from the University of Nairobi, an M.Sc. in International Supply Chain Management from the University of Exeter and AEVO’s international master trainer qualifications in vocational and work pedagogical knowledge, skills and abilities.



Alessandro Mele

President of Cometa, Cometa, Italy

Since 2004, Alessandro Mele has been involved in the Cometa Network, a social enterprise in the fields of care, education, social inclusion and youth employment, operating in Como with about 300 employees, 260 volunteers and 1300 beneficiaries. Mr Mele is President of the Cometa vocational school (600 students) and Secretary General of the IATH Academy, vocational school for tourism and hospitality (250 students). From 2016 on he has led the National Association of Colleges-ITS (Rete ITS ITALIA) as founder, president and now vice-president. He was a financial consultant in the Tax & Legal department of PWC.
